This rule will be applied to all sections of the report including the appendices and program code with comments. All flowcharts and diagrams must be prepared using Microsoft Office and not by hand. Any attempts to defeat the plagiarism checking software by submission of documents that include images instead of body text or any other mechanism will result in a grade of zero. The instructor or responsible grader reserves all rights to make this judgement and reject a project report if the above rules are not followed. Any violations may result in ACADEMIC DISHONESTY charges to be filed against the student.

Student waives all rights to a make-up exam if they miss a scheduled testing date. Any make-up testing will be at the sole discretion of the instructor.

Grade Replacement/Forgiveness and Census Date Policies

- ☐ Being reinstated or re-enrolled in classes after being dropped for non-payment
- □ Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog.
