Course Details

Description:	Introduction to basic Thermal/Fluid sciences laboratory procedures and practices. Experimental topics to include fluid flow, heat exchanger basics, and basics of refrigeration. Student teams will design, analyze and document an experimental procedure. All procedures will result in a professional quality laboratory report.
Credit hours:	2 (1 hour lecture and 3 hours laboratory per week).
Prerequisites:	MENG 3210, MENG 3401, MENG/CENG 3310, and co-requisite EENG 3308.

Textbook: No textbook is required. E-book by Dr. Rafe Biswas will be used in some chapters, and the books used in MENG 3210 and MENG 3310 are suggested.

Additional material: handouts, operating manuals, and material posted on CANVAS.

Expected Learning Outcomes

By the end of this course, students will be able to:

- 1. Apply fluid mechanics concepts for analysis of basic fluid mechanics experiments.
- 2. Apply heat transfer concepts for analysis of basic heat exchangers.
- 3. Apply thermal system concepts for analysis of refrigeration and heat pump cycles, and psychrometrics processes.
- 4. Design, perform, and report results of a mechanical engineering experiment.
- 5. Write professional quality laboratory reports.

Evaluation activities

- Exams: there will be two exams during the semester, the Mid-Term Exam and the Final Exam. The final exam will be comprehensive.
- Lab Assignments: for each laboratory activity, the given assignment must be submitted at the beginning of the following laboratory class. Instructions for the presentation of the assignment (report or data analysis or other) will be given separately.

- Quizzes: quizzes will be applied according with the topics covered in lectures and lab activities. Homework related to a quiz may be assigned one week before the quiz. When homework is assigned, it must be 100% completed and turned in with the quiz. If the homework is not turned in or is incomplete, the quiz grade will be zero.
- Student Design Lab Project: students will work in a design lab project of a topic assigned by the instructor. Students must plan the experiment, build the experimental setup, conduct the experiment, obtain data, validate the results, submit a report, and present the project to the class. Although the project will be completed in groups, the grade will be individual based on contributions.

Homework

Homework will not be graded, but it is required to take the quiz. Students are advised that if a question in a quiz is similar to a question in the homework, maximum partial credit will be 50 points. However, if the quiz is the same as the homework, no partial credit will be given.

Pop Quizzes:

To ensure that the students review any material given by the instructor prior the laboratory, pop quizzes can be applied.

Assignments Due Date:

Unless otherwise stated, all assignments are due one week after been assigned.

Homework/Quiz/Report Questions:

Questions involving knowledge covered in class (lecture/laboratory) will be answered if the student proves that they have tried to come up with the answer.

Homework/Quiz Solutions:

Solution to homework and quizzes will not be given. However, students can work on the right solution by checking their work with the instructor.

Student Behavior and Attitude:

8. Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office

of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

9. State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

10. Withdrawing from Class

Students you are allowed to <u>withdraw</u> (drop) from this course through the University's <u>Withdrawal Portal</u>. Texas law prohibits students who began college for the first time in Fall 2007 or after that from dropping more than six courses during their entire undergraduate career. This includes courses dropped at other 2-year or 4-year Texas public colleges and universities. Make sure to consider the impact withdrawing from this class has on your academic progress as well as the financial implications. We encourage you to consult your advisor(s) and financial aid for additional guidance. CAUTION #1: Withdrawing before census day does not mean you get a full refund. 11. Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the dean of the appropriate college may authorize an exception to the schedule after consultation with the faculty member involved. Faculty members are required to maintain student final examination papers for a minimum of three months following the examination date.

12. Incomplete Grade Policy

If a student, because of extenuating circumstances, cannot complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in lieu of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all course work or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor; and (c) the student presents these reasons prior to the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average for a student. The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to complete all work for the course average for the student, and assign the appropriate grade. If a grade has not been assigned within one year, then the Incomplete will be changed to an F or to NC if the course was initially taken under the CR/NC grading basis.

13. Grade Appeal Policy

UT Tyler's Grade Appeal policy requires the completion of a Grade Appeal form for this action to take place. The grade appeal begins with the instructor of your course. If you disagree with the instructor's decision, you may then move your appeal to the department chair/school director for that course. If you are still dissatisfied with the decision of the chair/director, you may move the appeal to the Dean of the College offering that course, who has the final decision. Grade appeals must be initiated within sixty (60) days from the date of receiving the final course grade. The Grade Appeal form is found in the <u>Registrar's Form</u> Library.
