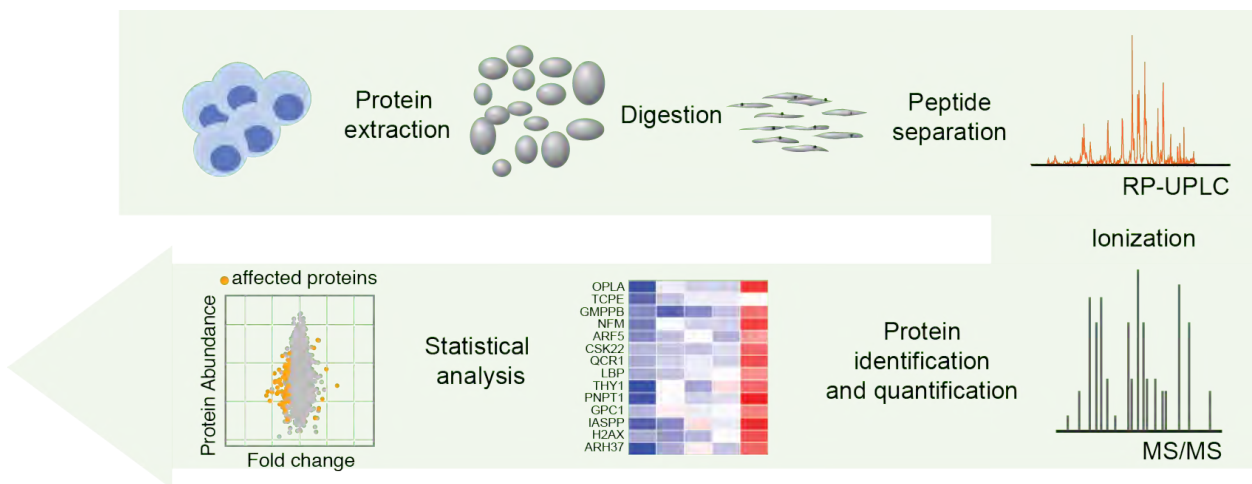

**Text:** Biochemistry: Concepts and Connections by Dean R. Appling, et al. and referenced papers.

**Course Content:** The course provides an introduction to the rapidly growing field of Proteomics. Proteomics is the study of the structure and function of proteins and their interactions within biologic systems. Proteins comprise the functional components of biologic systems and the course will explore their various roles as catalysts, regulators, and structural scaffolds. The course includes historical perspectives and implications for the field toward answering problems in the life sciences, including human health and disease. In addition, the course will provide greater depth in topics briefly discussed in Biochemistry I, such as the significance and effects of post-translational modifications to protein-protein interactions, as well as methodology for determining such modifications. Students will also be introduced to a global view of evaluating complex biologic systems and how an understanding of living systems through Proteomics can be utilized toward practical applications.

**Course Learning Objectives:**

- Gain a historical background and a firm foundation into the field of Proteomics
- Learn modern methodology and techniques for determining protein-protein interactions
- Learn common post-translation modifications, methods for their detection, and how these are exploited to modulate protein-protein interactions
- Learn how to integrate Proteomics globally for understanding complex organisms
- Learn how Proteomics can be practically applied toward solving persistent problems in human health and well being
- Develop skills in group collaboration via a group project requiring a written and oral presentation examining a modern application of Proteomics

**Grade Distribution:**

The overall grade will be determined by the student's performance on midterm exams, a group project that includes a written report and oral presentation, any assigned homework, and a final

cumulative exam. Examinations will cover all materials from text, lectures, and any assigned materials. Group projects will review a current topic in Proteomics and future outlooks for the impact that Proteomics hold in future practical applications. Homework sets will reinforce principles discussed in lecture, providing word-based problems that require students to identify and utilize principles to answer real world problems in Proteomics. The breakdown of these components to your final grade is as follows:

Final grades will be determined on a standard grading scale of A 90-100%, B 80-89%, C 70-79%, etc. Incentive points may be added, based on initiative, class participation, and improvement in the course.

### Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

### Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade *only when all of the following conditions are met:* (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade

roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

### **Grade Appeal Policy**

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
