HIST 1301: US History to 1877 (Online)

Course Objectives: Following the completion of this course, you will be able to:

- Explain the role and impact of national and international conflicts on America from pre-colonization to Reconstruction
- Identify significant events that occurred in early America, along with important individuals.
- Recognize and analyze significant social, economic, and political changes from pre-colonization to Reconstruction

Expectations: It is expected that everyone on this course to always be respectful to one another, even if the class is completely online. It is also expected that all exams and discussion assignments be submitted on or before the due date.

Methods of Evaluation:

3 major unit exams 75% (25 points each)

2 Online discussion activities 25% (12.5 points each)

* Important information about exams and assignments: Exams will be conducted online and will be timed. You are not permitted to use any resources, such as textbooks, notes, or your phone, during exams. If you miss an exam, you must provide an explanation and request a make-up test in writing, ideally via email. Any test missed without explanation or a valid excuse will result in a score of zero, and I reserve the right to reject your excuse. Make-up exams are only offered in cases of documented illness, legal issues, mechanical problems, or other emergencies.

It is your responsibility to arrange make-up tests, and you should contact me through the Canvas Inbox or email to explain your absence no later than the day after the test deadline or once your emergency has ended.

*Late submissions that do not have a documented/approved reason for being late will have 25% deduction from the final assignment grade if submitted within three days of the missed deadline. Submissions later than 3 days and do not have a documented/approved reason for being late will have 50% grade deduction. Also, it is important to note that I reserve the right to disqualify the excuse.

Discussion Instructions

Engaging in discussions with your classmates is crucial in History. In this course, you will take part in two class discussions, which are mandatory components of the curriculum.

Discussion Requirements

Your discussion posts should demonstrate thoughtful analysis and logical reasoning, backed by evidence supporting your viewpoint. Each post must be a well-developed paragraph of at least 100 words. Ensure correct spelling, punctuation, and grammar. All discussions should be submitted by the deadlines listed in the Course Schedule found in the Start Here Module.

Replying to Other Students' Posts

You must also read and respond to the posts of at least two other students for each discussion. Your responses should provide new well-supported ideas or insightful questions.

Each discussion topic is worth 12.5 points (12.5% each). The number of points you earn is determined as follows:

Grade Replacement/Forgiveness and Census Date Policies:

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware.

These include:

- o Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail, or Credit/No Credit
- o Receiving 100% refunds for partial withdrawals (There is no refund for these after the Census Date)
- o Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- o Being reinstated or re-enrolled in classes after being dropped for nonpayment

o Completing the process for tuition exemptions or waivers through Financial Aid State-Mandated Course Drop Policy Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- Using, buying, stealing, transporting, or solicitation in whole or part of the contents of an unadministered test, test key, homework solution, or computer program
- Collaborating with or seeking aid from another student during a test or other assignment without authority
- Discussing the contents of an examination with another student who will take the examination.
- Divulging the contents of an examination, for the purpose of preserving
 questions for use by another, when the instructors have designated that
 examinations are not to be removed from the examination room or not to be
 returned or to be kept by the student.
- Substituting for another person, or permitting another person to substitute oneself to take a course, a test, or any course related assignment
- Paying or offering money or other valuable things to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program

- Falsifying research data, laboratory reports, and/or other academic work offered for credit
- Taking, keeping, misplacing, or damaging the property of the University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct
- Misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially

o "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.

o "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.

o All written work that is submitted will be subject to review by plagiarism software.
