## HIST 1301: US History to 1877 (Online)

This course will cover the history, social, and political changes in North America (and later the United States) from pre-colonization to the end of Reconstruction (1877). Since this class is completely online, feel free to send me an email with any questions or concerns.

**Course Objectives:** Following the completion of this course, you will be able to:

- Explain the role and impact of national and international conflicts on America from pre-colonization to Reconstruction
- Identify significant events that occurred in early America, along with important individuals.
- Recognize and analyze significant social, economic, and political changes from pre-colonization to Reconstruction

**Expectations:** It is expected that everyone on this course to always be respectful to one another, even if the class is completely online, It is also expected that all exams and discussion assignments be submitted on or before the due date.

## Methods of Evaluation:

3 major unit exams 75%

2 Online discussion activities 25%

\*Note on exams and assignments: Exams will be online in a timed manner. Additionally, you are not allowed to use any resources (textbook, notes, phone) on your exams. If you miss a test, you must explain why and request a make-up test in writing, preferably through email. You will receive a score of zero for an unexplained or unexcused missed test, and I reserve the right to disqualify your excuse. Makeup tests are given **only** in cases of documented illness, legal cases, mechanical difficulties, or other emergency circumstances.

Makeup tests **must** be arranged by you, and you should contact me **through the Canvas Inbox or email** to excuse your absence, **no later than** the next weekday after the test deadline or at the end of your emergency.

## Timeframes for Taking Tests

## Discussion Instructions

Discussion with your classmates is a vital part of learning. In this course, you will participate in 2 class discussions in this course. These discussions are a required part of the course.

## Discussion Requirements

Your posts in the discussion area should portray careful thought and logical reasoning and provide evidence for your position. Each post should be at least one well-developed paragraph (approximately 100 words or more). Use correct spelling, punctuation, and grammar. The discussions must be completed by the due dates specified on the Course Schedule in the Start Here Module.

## Replying to Other Students' Posts

You are also required to read and reply to the posts of at least two other students for each discussion. Your replies should offer new substantiated ideas or thoughtful questions.

## Grading

Each discussion topic is worth 50 points (12.5% each). The number of points you earn is determined as follows:

### **Grade Replacement/Forgiveness and Census Date Policies:**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or by clicking this link. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware.

These include:

- o Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail, or Credit/No Credit
  - o Receiving 100% refunds for partial withdrawals (There is no refund for these after the Census Date)
  - o Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
  - o Being reinstated or re-enrolled in classes after being dropped for nonpayment
  - o Completing the process for tuition exemptions or waivers through Financial Aid State-Mandated Course Drop Policy Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

### **Student Standards of Academic Conduct:**

Disciplinary proceedings may be initiated against any student who engages in scholastic dishonesty, including, but not limited to, cheating, plagiarism, collusion, the submission for credit of any work or materials that are attributable in whole or in part to another person, taking an examination for another person, any act designed to give an unfair advantage to a student or the attempt to commit such acts.

If the professor determines you have engaged in cheating within the course, you will automatically fail the assignment or exam. If a second offense occurs, you will receive an automatic failing grade for the course. There are no exceptions to this policy.

"Cheating" includes, but is not limited to:

- Copying from another student's test paper
- Using, during a test, materials not authorized by the person giving the test.
- Failure to comply with instructions given by the person administering the test.



- Possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes." The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test.
- Using, buying, stealing, transporting, or solicitation in whole or part of the contents of an unadministered test, test key, homework solution, or computer program
- Collaborating with or seeking aid from another student during a test or other assignment without authority
- Discussing the contents of an examination with another student who will take the examination.
- Divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors have designated that examinations are not to be removed from the examination room or not to be returned or to be kept by the student.
- Substituting for another person, or permitting another person to substitute oneself to take a course, a test, or any course related assignment
- Paying or offering money or other valuable things to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program
- Falsifying research data, laboratory reports, and/or other academic work offered for credit
- Taking, keeping, misplacing, or damaging the property of the University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct
- Misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially

o "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.

o "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.

o All written work that is submitted will be subject to review by plagiarism software.
