- Understand and explain the major events and figures that have shaped Texas history
- Analyze the social, cultural, and political developments in Texas over time
- Outline and explain the diverse experiences of various groups in Texas
- Develop critical thinking and analytical skills through historical inquiry

Methods of Evaluation:

Exams (45%) – Students will take two major exams in this course. Both exams will include a variety of question formats, including, but not limited to short answer, true/false, multiple choice, and essay.

Class Participation (30%) – In addition to attendance, any daily quizzes and/or assignments will fall into this category. We will take at *minimum* two off-campus class "field trips." If you are unable to attend, you *must* complete an alternative assignment.

Research Paper (25%) - Each student will select a topic that is relevant to our course. Research papers are due by 11:59 pm on November 22. Papers must meet the following parameters:

- You *must* use at least five academic secondary sources. You are encouraged, but not required to utilize primary sources in your research.
- Your paper *must* be properly formatted in the Turabian/Chicago style. Your paper should be double-spaced and written in Times New Roman 12-point font with one-inch margins.
- The final paper *must* be between eight and twelve pages. Please note that your cover page, footnotes/endnotes, and bibliography do *not* count towards your overall page length.
- One letter grade will be deducted for *every* calendar day the paper is late.
