## Course Overview and Objectives:

This is an upper-level survey of the history of Russia from its medieval origins to the present. After briefly examining the period from the tenth through the seventeenth centuries, we will then take a more detailed look at the growth of the Russian Empire from 1700 to its collapse during the First World War. From the midterm on, we will study the rise and fall of the Soviet Union, followed by a short survey of post-Soviet Russia. We will explore Russia's social, cultural and economic history along with its leaders and their governments in terms of both domestic and foreign policies.

# Course Requirements:

The course will consist of lectures and discussions; regular attendance and participation are essential to success but are not assessed quantitatively. There will be a midterm exam, a final exam, and a term paper. Each of these will be worth 1/3 of your final grade. The exams will consist of paragraph long identification terms (a choice of 5 out of ten for a total of 50 points) and a longer essay worth fifty points, for a total of 100 points. The term paper will be an analysis of the books by Harris and Solzhenitsyn and is also worth 100 points.

## **Grading Policy:**

Each of the three assignments (midterm, final, term paper) is worth 100 points for a total of 300 points. The grading scale is as follows:

A = 270-300 points

B = 240-269 points

C = 210-239 points

D = 180-209 points

F = 0-179 points

Makeup exams will not be given, nor will late papers be accepted; the only exceptions being officially documented medical or family emergencies. Plagiarism of any sort will not be tolerated and will result in an F for the course.

## Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)

Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)

Being reinstated or re-enrolled in classes after being dropped for non-payment.

Completing the process for tuition exemptions or waivers through Financial Aid

## State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog.
