A study of selected primary texts by rhetoricians from the classical ages to the present and of recent scholarly theories and commentaries. Topics might include changing definitions and constructions of rhetoric, the Sophists, the relation between rhetoric and epistemology, and the role of rhetoric in the history and development of liberal education.

The submitted work should include the exact prompt that you used to generate the content and the AI tool's complete response as an appendix. Because AI-generated content is not necessarily accurate or appropriate, you must assess the validity and applicability of any submitted AI output. You will not earn full credit and may fail an assignment if inaccurate, invalid, or inappropriate information is found in your work. Further, the majority of the paper should not be AI-generated content. Papers that have substantial AI-generated content will fail.
