**Description of the Course:** The course introduces students to a wide variety of visual, audio, and written texts and teaches critical textual analysis in Spanish. Deepening and enhancing students' knowledge of the expression of literature/culture within Latin America, Spain, and the U.S., the course gives students ample opportunities to practice and improve their reading, listening, and textual analysis skills while expanding their vocabulary and reviewing critical grammar structures. Students will gain the skills to critically approach a literary/cultural text, synthesize its main points, and prepare multimodal analyses all within a communicative context.

**Recommended Prerequisite:** Successful completion of Spanish 2611 or its equivalent.

**Course Objectives/Learning Outcomes:**

- to expand and perfect knowledge of and grammatical structures.
- to improve reading and writing skills.
- to develop critical thinking abilities.
- to increase awareness and understanding of Hispanic literature and cultural expression.

**Course Requirements**

**Textbook Activities:** Each student will need to complete and turn in textbook activities assigned by the instructor. Activities may be individual, or group based.

**Chapter Projects:** Each student will complete short projects/writing assignments/papers related to textbook prompts from each chapter studied during the semester. Specific requirements/details will be given by the instructor.

**Chapter Quizzes:** Quizzes will be given in-class over grammar topics and (possibly) specific vocabulary/topics/terminology related to each chapter. The instructor will announce the dates of each quiz on Canvas and in class.

### **Incomplete Grade Policy**

---

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

## Grade Appeal Policy

---

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
