Course Overview

The below course description and learning outcomes are per the Texas Higher Education Coordinating Board *Lower-Division Academic Course Guide Manual* Spring 2021:

Course Description

Intensive study of and practice in the strategies and techniques for developing research-based expository and persuasive texts. Emphasis on effective and ethical rhetorical inquiry, including primary and secondary research methods; critical reading of verbal, visual, and multimedia texts; systematic evaluation, synthesis, and documentation of information sources; and critical thinking about evidence and conclusions.

Learning Outcomes

Upon completion of this course, students will:

- Demonstrate knowledge of individual and collaborative research processes
- Develop ideas and synthesize primary and secondary sources within focused academic arguments, including one or more research-based essays
- Analyze, interpret, and evaluate a variety of texts for the ethical and logical use of evidence
- Write in a style that clearly communicates meaning, builds credibility, and inspires belief or action
- Apply the convention of style manuals for specific academic disciplines (e.g., APA, CMS, MLA, etc.)

Catalog Course Description

This course familiarizes students with writing in academic disciplines through critical reading and writing under supervision. Students develop writing skills through analysis and evaluation of rhetorical conventions of academic writing in and beyond their own disciplines.

Learning Outcomes from Reading and Writing about the Disciplines

Upon Completion of this course, students will be able to:

- Recognize the rhetorical conventions characteristic of writing in a discipline they wish to purse as a major
- Review, analyze, and evaluate writing in the disciplines for a designated purpose
- Use the style of writing and documentation appropriate to the discipline
- Summarize, paraphrase, and synthesize texts accurately and effectively
- Select and incorporate material from sources professionally

Laptops

Attendance Policy

Minimum Requirement to Earn a C in the Class

Public Writing

All writing in the class is public writing. As a class, and possibly in small groups, we will discuss what is working well in student projects and areas for improvement.

Grade Components

Detailed information on the projects, including grading criteria, will be provided in class and via documents in Canvas.

Projects

The research report is a report on finding a topic in your field that you are interested in and finding scholarly sources on that topic. The compare and contrast paper is an analysis of the writing conventions used in scholarly articles. The poster presentation is a visual presentation of a topic relevant to you. The end-of-semester reflection is a reflection on what you learned over the course of the semester.

The research report, compare & contrast analysis, and poster presentation can be revised for a potential higher grade. Details will be provided in class.

Engagement Work

Engagement work is written responses to various prompts, drafts of assignments, and contributing to discussion board threads. Engagement work is graded as complete or incomplete which is how Canvas handles pass/fail grading:

• Complete: Meets expectations and is submitted on time

• Incomplete: Does not meet expectations and/or is not submitted on time

In most cases, engagement work cannot be revised or submitted after the due date. There may be situations which warrant an exception to this policy. If you cannot submit engagement work due to an illness or emergency, notify me as soon as possible. I will determine if an exception is appropriate. Documentation may be required.

Recurring engagement work that is graded as incomplete precludes exceptions.

Information Literacy Quizzes
