# English 5389 (Online) Composition Practicum

Course Description: Focusing on effective teaching of writing, this course is a study of theory of literacy and composition pedagogy, extending the topics covered in ENGL 5390 to practical application. It will cover topics and their historical contexts essential for successful writing instruction, such as how to align the syllabus with writing assignments, how to develop a thematic sequence of writing assignments with specific learning outcomes for each of the assignments, and how to use writing assessment as a teaching tool, etc. All assignments are scaffolded to enable you to develop a first-year writing course of your choice. In other words, this course is scaffolded and built to guide your creation of an overall teaching portfolio as a culminating product based on your understanding of theories behind it.

Objectives: Students who successfully complete the course will be able to:

- Understand writing as technology to reflect on the writing economy,
- Write critical responses to scholarship in composition studies
- Understand how literacy, basic Aristotelian rhetoric, and composition pedagogy have shaped today's writing instruction,
- Design a writing course with a thematic sequence of assignments and assessment plans
- Analyze and critique textbooks, classroom observations, syllabi, writing assignments, and assessment plans
- Design and manage writing workshops/activities effectively to create a student-oriented learning environment
- Demonstrate understanding of ways technology aids writing instruction

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (January 30, 2017) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for nonpayment
- ullet Completing the process for tuition exemptions or waivers through Financial Aid

## State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university.
