Math 2413 DC Calculus Syllabus for Spring 2025

Course Description: A study of functions, limits, continuity, differentiation, applications of the derivative, the definite and indefinite integral, and applications of integration. These topics can be found in chapters one through five in the text.

Student Learning Outcomes

Upon completion of this course the students should be able to:

- Discuss the solution to the tangent and area problems involving the calculus concepts of limits, derivatives and integrals.
- Use graphs of algebraic and transcendental functions to determine limits, continuity, and differentiability at a point.
- Determine whether a function is continuous and/or differentiable at a point using limits.
- Apply differentiation rules to differentiate algebraic and transcendental functions.
- Choose appropriate calculus concepts and techniques to provide mathematical models of real-world situations and determine solutions to applied problems.
- Compute definite integrals using the Fundamental Theorem of Calculus.
- Recognize and discuss the relationship between derivatives and integrals using the Fundamental Theorem of Calculus

Grade Calculation Homework 10%, Quizzes 30%, Average of 3 Tests 30%, Comprehensive Final Exam 30%[or 40%].

Quizzes will be composed of problems similar to homework. This means that if you keep up with your homework, you should do very well on your quizzes. Instead of giving makeup quizzes, I will drop the lowest quiz grade for everyone when I average them. If you do have to miss a quiz for any non-school related reason, that grade will be a zero until I drop it at the end of the semester. If you miss a second quiz, that grade will remain a zero. In addition, if you miss a test, that grade will be a zero until you take the final exam, at which time I will substitute the final exam grade for the missed test. If you don't miss any tests and your final exam grade is better than one of your 3 tests, I will substitute the final exam grade for that low test grade. Departmental policy is that you can only make one grade higher in the course than you make on the final exam.

Calculator No calculator will be used for quizzes or tests. You can use any calculator you wish to assist with homework but keep in mind that you won't have access to it on assessments.

Attendance Class attendance is very important to your success. I will take roll once at the beginning of each class. If you come in late, notify me at the end of that class – otherwise you will be counted absent.

Cell Phone Policy When it is time for class to begin, please turn your cell phone to silent or off and put it out of sight.

Homework There will be daily homework assignments. These are very important. The best way to learn mathematics is to work mathematics problems. They will not be collected but will be checked for completion at the end of each week.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date

January 27th is the deadline for many forms and enrollment actions that students need to be aware of. These include:

• Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

• Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)

• Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)

• Being reinstated or re-enrolled in classes after being dropped for non-payment

• Completing the process for tuition exemptions or waivers through Financial Aid

UT Tyler a Tobacco-Free University:

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
