Course Overview:

Weekly applied lessons on the flute. Students will study flute technique, sight-reading, and flute literature and etudes appropriate to their experience level. All students in applied lessons are required to attend the weekly studio class and all student degree recitals.

Student Learning Outcomes:

- Demonstrate mastery of the fundamentals of flute playing including embouchure, tone quality, and air support.
- Perform with technical and artistic skills appropriate for the student's level.
- Gain and apply fluency of musical styles, genres, and performance practice through performance in lessons, juries, and recitals.
- Understand flute pedagogy at the level appropriate to their degree, demonstrate this knowledge through practical application in weekly lessons.

Required Textbooks and Materials:

All students are required to have a flute in good repair, cleaning and maintenance materials, and the repertoire assigned in lessons. Major repertoire projects will be decided between the student and professor in the first week of classes.

Attendance at Recitals and Flute events:

It is required to attend all student degree recitals (junior or senior recitals) and the studio recital at the end of the semester.

All students in 30 minute lessons are required to perform in studio class OR in the weekly recitals.

All students in 1 hour lessons are required to perform in studio class AND in the weekly recitals.

Weekly Lessons and Studio Attendance: Students will attend weekly lessons and studio class to improve their musicianship, technique, and tone quality. The student and instructor will decide collaboratively on performance goals for the semester and create a plan of individual practice in between lessons. Students are expected to come prepared to each lesson, having practiced all assignments from their previous lessons. Students will receive a grade each week for their lesson based on the rubric available on canvas.

Final Jury: Each student will complete a jury at the end of the semester or recital during the semester (as required in the degree plan)

Studio/Student Recital Performances: All students in 30 minute lessons are required to perform in studio class OR in the weekly recitals. All students in 1 hour lessons are required to perform in studio class AND in the weekly recitals.

Listening Assignment: Students will complete one listening assignment during the course of the semester. The assignment will be related to the repertoire the student is studying in lessons and consists of a presentation given during studio class detailing the biographical information about the composer, performer, the piece, and their insight gained about the pieces from listening.

Technique and Sight-reading Quiz: Students will complete one technique quiz in the middle of the semester. The quiz will test the student's knowledge and mastery of the given material. The instructor will assign scales, arpeggios, or exercises that are appropriate for each student's individual level of playing and the student will perform the assigned exercise memorized at an agreed upon tempo, and level-appropriate sight-reading.

Attendance at flute events: Students are required to all studio degree recitals and other fluterelated events (with advance notice). This includes degree recitals by other students, faculty recitals, chamber recitals, and large ensemble concerts.

Late Work and Make-ups:

Lessons will be made-up during the semester via Zoom or at the end of the semester in-person. In order for a lesson to be eligible for a make-up, the student must notify the instructor of the cancellation or sick day prior to the scheduled lesson time.

The Technique Quiz and Listening Assignment presentation will be rescheduled within a week of the original due date.

Attendance Policy:

Students must attend all lessons, studio classes, and their final jury. If the student needs to cancel a lesson, they must email the instructor prior to the day of the lessons. Absences will be excused (with lessons rescheduled) for illness, family emergencies, and other circumstances outside of student control. Unexcused absences (no call/no show) will result in a lower grade.

Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average. The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the <u>Registrar's Form Library</u>.

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
