Course Overview:

Through this course, the student will:

- Cultivate and elevate technical skills on bassoon.
- Expand and develop musicianship skills through experimentation with bassoon as the performance medium.
- Learn tactics for sightreading music.
- Explore a vast repertoire of bassoon music from different eras and compositional styles.
- Build a working knowledge of reed-making and adjustment.
- Develop self-sufficiency in the act of music preparation.

Student Learning Outcomes:

Through this course, the student will be able to:

- Discuss the general pedagogy of bassoon technique.
- Develop independent musical thought and phrasing.
- Sightread music of appropriate difficulty
- Recall music for bassoon from a variety of eras and compositional styles.
- Troubleshoot and adjust bassoon reeds.
- Devise a practice plan for new music.

Required Materials:

A Functional Bassoon

Three high-quality reeds at every lesson and performance.

Recommended Reedmaking Tools and Materials: (Not Required)

- Gouged/shaped/profiled cane (Preferably Herzberg-shaped)
- 6 inch ruler- With both imperial and metric markings)
- Forming Pins & Handle. Nexus Woodwind Long Forming Pins (10 pins minimum)
- Wire (22 gauge gold-brass)
 - I recommend buying a pound at a time. You'll continually use it over time.
- Reamer (choose one)
 - Barry Stees Reamer
 - Rieger (Spiral Fluted)
- Pliers (choose one)
 - Rieger
 - Reeds n Stuff
- Plaque (choose one)
 - Rieger plastic contoured (purchase a couple)
- Sealing Agent: (Choose one or both)
 - Thread & Duco Cement
 - Hot Glue & Glue Gun (High Temp)
- Reed Knife (Double Hollow Ground)
 - Chiarugi
 - 2X (Miller Marketing Co)
- Files
 - Grobet Extra Narrow Pillar Precision Files (4" in both 2 & 4 cut)
 - Diamond File Needle 3 Square 170/220 Grit Fine
- Sandpaper, 1000 Grit
 - (This comes in sheets, and you will cut it into smaller squares)
- Dial Indicator- Metric
 - Nexus Woodwind Specialty

- Easel (6 inch dowel with score mark for middle)
 - Nexus Woodwind
 - Stees is flat on the bottom, which allows you to set it on the table without rolling.
- ¼-28 NF Drill Tap
 - (available at most hardware stores)

Reeds Requirement:

You do not have to make your own reeds. However, you must always have at a minimum of three high-quality reeds in your case. As reeds wear out, you must start rotating new reeds in to keep yourself perpetually stocked.

Performance majors will make 5 reeds from gouged, shaped, and profiled cane.

Education, Composition, BA, minors, and non-majors are all welcome to learn how to make reeds from gouged, shaped, and profiled cane.

Grades:

Each lesson will be graded on preparation and progress. While the expectation is excellence through diligence, the measurable long-term improvement is the primary grading criteria. Each week, the student will be given lesson assignments to prepare for the following week. Progress on these skills will be gauged and measured through the semester.

Final Exam:

Every student will perform a final exam through degree recital or a juried performance in front of the woodwind faculty during finals week. The repertoire of the juried performance can include solo repertoire and ensemble excerpts.

Attendance:

Please show up for your lessons on time, prepared, and ready to work. This means show up to the assigned meeting place 5 minutes before to unpack your instrument & soak your reeds.

If you are sick, please do not come and let me know by 9:00am that morning. We will work to reschedule or create an alternative assignment. Makeup/alternative assignments could be a listening review, recording project, or a lesson plan for teaching an excerpt of music.

Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade *only when **all of the following conditions are met***: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the

rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the [Registrar's Form Library](#).

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
