COURSE DESCRIPTION: This course is designed to introduce you to the process of studying "Classical" music which includes a brief overview of the development of Western music from the Middle Ages to the Modern era. This course fulfills the university Core Curriculum requirement in Creative Arts for all majors.

COURSE OBJECTIVES: The objective of *Music Appreciation* is for the student to gain an understanding of the development of Western music from the early sources until the present day. The course will include the study of both sacred and secular music in all genres. It will place a strong emphasis on listening to and identifying various styles of music. Upon successful completion of the course, students will be expected to:

- Apply basic musical terminology and develop listening skills for musical details relating to rhythm, melody, harmony, texture, and form
- Become familiar with instrumental families and the basic production of sound on these instruments
- Demonstrate a basic knowledge of significant composers and works for each period of Western music history
- Identify the various genres of music and trace their development through the major historical periods.

CLASS FORMAT & PACING:

This course will be taught online using Canvas modules, the Listen 10th edition ebook resources, and supplemental PowerPoint exam review slides. This class is asynchronous (not a live stream), however, the readings and assignments follow a traditional MWF schedule to keep you on track to complete your work and not fall behind. You are welcome to work ahead on assignments that are available early.

<u>Please Note: Each test/assignment has a strict due-date. There are no make-ups for missing test/review deadlines.</u>

REQUIREMENTS FOR CREDIT:

PARTICIPATION: Students are responsible for logging into the course to read the online Illumine ebook chapters and answer embedded questions, complete Inquisitive/other assignments, exams, the group project, read announcements, and refer to the course schedule. Logging in daily is recommended. Failing to do so is comparable to failing to participate in a traditional face-to-face class.

METHODS FOR ASSESSING OUTCOMES: Students will be evaluated through six (60 minute) Online Reading/Listening using Canvas. You are NOT allowed to have any books, notes, papers, etc. or any other electronic devices accessible during the exams. Be sure to use a computer in a quiet space with a good internet

connection for the online exams. Students will also be evaluated through various assignments including one short typed essay (1 paragraph) on "What is Music?" at the beginning of the semester and one short 3-5 minute self-video on "What is Music?" at the end of the semester, weekly *InQuisitive* online skill building assignments through the Total Access 10th Edition Textbook *Listen* designed to be entertaining and educational, embedded questions within the Illumine ebook chapters to test your comprehension, online Canvas assignments/reviews, and two concert program attendances with brief reports. Concert reports and the essay assignment will be graded for grammar and format as well as content. The concert report template will be found on Canvas Modules under "Assignments" and there will be a list of approved concerts posted at UT Tyler that are free listed under Announcements. If students want to attend a concert outside of the list, the student must consult the instructor prior to the concert attendance for approval. You may attend two additional approved concerts and turn in the program and brief report for extra credit.

GROUP COLLAGE PROJECT: Students will create a free account on Google Slides. At the beginning of the semester, the instructor will assign each student to a group. A group will consist of 7-10 students & each group of students will collaborate to create an interactive "Picture/Word Collage" that consists of one slide with overlapping pictures, text, graphics, etc. All students will contribute to the group collage equally. Students can contribute remotely to the collage via Google Slides adding color, design, text, pictures, graphics, backgrounds, short videos, etc. Avoid misspelled words and capitalization errors. Each group leader is responsible for communicating with the group and posting the assignment. Group members will explain the content in their group collage on the discussion board. Everyone will view all other collages and comment.

The collages will center on "Jazz" which originated in America (chapter 24). Each group will be assigned to a jazz related topic listed on Canvas Modules under "Group Collage Project." Each Collage Group must:

- 1. Elect your group leader and notify the instructor via email by **September 8th**. This person will submit a JPG file of the collage and upload 4 music video links to the assignment and coordinate with the group.
- 2. The group leaders will report to the instructor if everyone is responsive and collaborative on the project by **October 22nd** and also submit a preliminary JPG file to the assignment.
- 3. Each student will contribute at least FOUR items to the collage.
- 4. There must be 4 YouTube video links submitted with the collage to an appropriate jazz musician/band/history/etc.
- 5. Final corrected JPG of collage and 4 video links posted by the group leader to the corresponding discussion board with each student in the group posting a 3-5 sentence comment explaining different aspects of the collage content due by **November 27th**.
- 6. All other students must post one sentence thoughtful comments on the other 9 collages due by **November 29th**.

GRADE REPLACEMENT/FORGIVENESS AND CENSUS DATE POLICIES: Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept 1) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept 1) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

STATE-MANDATED COURSE DROP POLICY: Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
