# **Course Description**

This course is the advanced vocal pedagogy course that addresses teaching various genres of singing including but not limited to classical, pop, jazz, musical theater, rock, and country. Students will also learn how to integrate the business and leadership strategies to promote their music career as a teacher and singer. They will learn how to set up their private voice studio using marketing, SWOT analysis, blue ocean strategy, and social media.

Students will be able to:


- 1. Understand their purpose as a teacher and singer.

- 3. Learn how to approach various vocal issues and teach various singing genres.
- 4. Establish appropriate vocal exercises and apply various exercises depends on the vocal issues presented during the lessons.
- 5. Develop a business plan for a private studio by using marketing, blue ocean strategy, and SWOT analysis.


# **Attendance and Course Requirements**

Attendance is required for all scheduled classes. More than three absences (for any reasons) will lower the final letter grade. Class assignments include reading summary, research, learning assigned music, and others. Students will organize their portfolios in a three-hole binder. No late submission of assignments will be accepted.

## **Course Activities and Grades**

## 1. Attendance: 30%

Attendance is important for this class because we will be exploring various vocal sounds and demonstrating teaching during the class time. More than three absences, regardless of the reasons will lower the final letter grade.

# 2. Identity, Vision, and Intention Statement: 10%

We will learn how to find the purposes as a teacher and singer and execute our visions and missions in pursuing our career. We will write down the IVI statement at the beginning and the end of the semester to compare how we develop our intention and purpose throughout the semester.

# 3. Teaching Demonstration (Classical): 15%

Students will demonstrate how to implement pedagogical theories into real-time lesson with a student. The instructor will recruit several different students and invite them to the class. Students will teach classical techniques during this demonstration.

# 4. Teaching Demonstration (Commercial): 15%

Students will demonstrate their teaching of non-classical singers. The instructor will recruit singers who will sing various genres. Students will apply their knowledge about commercial singing pedagogy during this demonstration.

# 5. Vocal Exercise Presentation (Classical): 10%

Students will develop five vocal exercises that will address specific vocal issues presented by their students. They will present each vocal exercise with the rationale and the application. This portion of presentation is strictly for classical singing.

# 6. Vocal Exercise Presentation (Commercial): 10%

Students will develop five vocal exercises that will address specific vocal issues presented by their students. They will present each vocal exercise with the rationale and the application. This portion of presentation is strictly for non-classical singing.

## 7. Business Plan: 10%

Students will develop their business plan for their private studio. They will use blue ocean strategy, marketing, and SWOT analysis. They will provide a mission statement (1-2 sentences) and teaching philosophy (4-5 sentences) on their presentation.

## Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three

course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W"grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

## State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
