Course Description:

This course is an examination of the Texas political system, including its intellectual foundations and the design of the Constitution. It includes study of the major institutional factors, the impact of interest groups and the media, and the processes of policy-making. It may be taken in fulfillment of statutory requirements for a baccalaureate degree.

Content Objectives:

The primary goal is to successfully complete a required course with minimal pain and suffering while gathering useful information. To that end, after successfully completing this course, students should be able to demonstrate:

- To acquaint you with the study of political science, and
- To improve your understanding of the institutions and processes that govern Texas and other states, as well as the localities (such as cities and counties) within them.
- The student will become familiar with the historical antecedents which make up the political culture and regions of Texas.
- The student will learn to characterize the trends in Texas’ political history.
- The student will be able to trace the changing political partisan face of Texas from a one-party Democratic state to a state with a strong Republican party.
- The student will become cognizant of the changes facing Texas in ethnic diversity and population growth.

Important Note:

I encourage you to meet or message with me regularly to discuss or clarify lectures videos, or reading—or to talk about government or history in general. Please keep this in mind throughout the semester.

Also, some semesters, life gets in the way. Should you have one of these semesters, I am more than happy to talk to you about what to do. But if the trauma is too great, I strongly suggest you drop one or all of your courses. Your education is vitally important, but there are things that outrank even education sometimes—and *you have to make that call when it is necessary*. I cannot grade you on how well or poorly you deal with your life at given moments. Your grades reflect your performance in class—not how well you are dealing with other things. I wish all of us a semester in which these things aren't issues.

Required Reading and Materials:

Textbook:

The textbook is a free PDF – *Uncovering Texas Politics*. You will also be given book chapters and other materials that will be uploaded onto Canvas. They are a required part of the course and you are responsible for the information presented in them. There is no official textbook for you to purchase.

Course Structure:

This course will be conducted in four units and there will be one exam over the material in each unit. There is also a comprehensive final exam that is optional unless you miss an exam. You will have weekly assignments in Canvas. Check Canvas for due dates.

You are expected to log on each multiple times a week and complete work in the current module. Waiting until the last minute to do the assignments is not advised. Having a computer issue, internet issue, Canvas issue, or any other issue on the end of the day that assignments due is not an excuse for not completing them, and no additional time will be granted. If you do the work early and an issue presents itself, then there is time for us to work together and resolve it so that you can submit the work by the due date. The university has computer labs for you to use and most places have free wifi available now. If all else fails, Canvas has a cell phone app.

Also, as all quizzes, assignments, and exams are available online for some period of time. **Module assignments and submitted late are reduced 50% of the grade per day, exams cannot be taken late.**

Course Attendance Policy:

The attendance policy is that you should be logging on multiple times each week and working on a module and completing assignments. You should not be waiting until the due date to do everything. The University recommends that you spend at least 3 hours (not including reading the textbook) working in each class. If this was a face to face class, you would be meeting in person for that amount of time and doing reading and homework outside of class.

Online Quizzes:

There will be 12 quizzes, each consisting of 20 multiple-choice and true/false over the lectures, textbook, and other content for each chapter module. Each quiz is worth 20 points. Quizzes are designed to help familiarize you with at least some of the important material that will be on the exams and to make sure you are reading. These quizzes are open book and open note. One quiz grade is dropped at the end of the semester, for a total of 220 points. The syllabus quiz grade will not be dropped. **Module quizzes submitted late are reduced 50% of the grade per day.**

Online Assignments:

There will be 15 article or video quizzes over the course of the semester and they will be worth 3 points each. There is one assignment that is worth 2 points. Total points available is 50. **Module assignments submitted late are reduced 50% of the grade per day.**

Writing Assignments:

There is a writing assignment essay that is worth 20 points. This grade is not dropped, and you are not allowed to turn an AI generated paper for the assignment. Total points available is 20. No late work is accepted on the essay.

Online Exams:

There will be four-unit tests. Each exam will consist of a mixture multiple choice and true/false questions for a total of 100 points. There is a study guide posted for each exam. If you miss a test, there are no make-up exams given for individual exams. At the end semester, students who missed an exam will take the final exam as a grade replacement. Students who did not miss an exam do not have to take the final, but if they choose to, it will replace their lowest exam grade. See schedule below for due dates. Test count for a total of 400 points.

No late exams are allowed.

Exam Policy:

No lockdown browser or proctoring software is required for exams or quizzes this semester. However, exams are NOT open book or open note and outside resources, like google, are not allowed. To ensure academic honesty, you may not click out of the exam while you are taking it and there is a time limit. These measures are taken because I do not require a lockdown browser or test monitoring software on exam since they generally make students have anxiety and score poorly. Violation of these can result in a 0 on the exam and further action being taken.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another

2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

 - using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
 - collaborating with or seeking aid from another student during a test or other assignment without authority;
 - discussing the contents of an examination with another student who will take the examination;
 - divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
 - substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
 - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
 - falsifying research data, laboratory reports, and/or other academic work offered for credit;
 - taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
 - misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
