

## Time and Place of Class Meetings:

<u>Asynchronistic (ON OWN TIME):</u> Students are expected to engage in all course material and complete all assignments following the order of the course schedule and due dates. As students are senior-level preprofessionals, it is understood time management is at each individual's discretion.

**Course Overview:** The purpose of this course is to provide students with opportunities to share and report progress on achievements or challenges of learning tasks in their Field Practicums, including use of both empirical knowledge and reflection of practice-based skills including engagement, assessment, intervention, and evaluation in micro and macro environments.

**Description of Course Content**: This course will explore ethical issues, dilemmas, problem-solving and skill acquisition in Field Practicum, providing both peer and instructor support and feedback. This course will also examine life-long learning, job seeking, job interviewing, professional networking, state certification, state licensure, professional memberships and graduate MSW application opportunities.



# **Descriptions of Assignments:**

#### **Journal Entries (40 % of Final Grade)**

Students will submit five (5) journal entries, utilizing the prompts provided by the instructor. Each journal entry should demonstrate both reflection and critical thinking skills. Topics for the journals are ethics, resource gaps, client interaction, use of macro skills and what am I missing. In addition to their own five (5) entries, each student must post a helpful and well-though out response to at least one (1) other student's journal entry during the semester. Additional details for this assignment may be found in the class Canvas under the "Assignments" section.

## **Preparation for Professional Life Training (30% of Final Grade)**

Students will choose at least one of the following instructor-provided activities to attend and complete:

- 1) LBSW Exam Ready or Not
- 2) Job Search in the Lost and Found
- 3) Graduate School Get Ready

## Attend and Be Attuned (10% of Final Grade)

Each student will attend at least one synchronistic class to process events occurring in field and/or to provide support to their field practicum peers. Students are encouraged to attend more, if able and find beneficial. If a student is unable to attend during scheduled synchronistic course times (which also serve as the instructor's office hours for this course), alternative times may be arranged. ## **Evaluation of Practicum (20% of Final Grade)**

To better educate and/or advocate for self and future social workers, students are to complete the field practicum experience evaluation, which employs both quantitative and qualitative feedback. #### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waiver through Financial Aid State-Mandated

# **Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
