1 Description

Economics is the study of how individuals and society choose to allocate their limited resources. This course provides an introduction to microeconomics, which analyzes the behavior of consumers and producers and the structure and performance of markets. In this course, we will study the basic economic problem of scarcity and the implications for specialization and trade. In addition, we will study the behavior of consumers and producers in a competitive economy and how markets determine the allocation of resources. Finally, we will apply the material to investigate how government policy affects markets and the performance of the economy.

Learning Outcomes: At the successful completion of this course, the students will be able to

- i. Understand the basic economic problem and how it relates to the notions of scarcity and efficiency.
- ii. Understand how markets work, including the determinants of demand and supply and how demand and supply determine the market equilibrium and the allocation of resources.
- iii. Apply demand-and-supply analysis to determine how changes in economic conditions affect the equilibrium in different markets.
- iv. Apply the material to investigate how government policy affects markets and the performance of the economy.

The students will learn the material by attending lectures, reading the textbook, and completing a number of homework assignments. The comprehension of the material will be measured by the performance of the students on the homework assignments and examinations.

2 Prerequisites

There are no formal academic prerequisites for this course.

a. Textbook

The required textbook for the course is *Principles of Economics* by Asarta and Butters (McGraw-Hill). You are required to purchase the "online course package" which includes (i) an electronic version of the textbook and (ii) the Connect learning system. You will be using the Connect learning system to access the textbook and complete the online assignments. *For more information, go to the Getting Started section in Canvas*.

b. Mathematics

Mathematics is a powerful tool for economic analysis, but in this course I will present the material in a non-technical form, based mostly on numerical and graphical analysis and intuitive explanations.

3 Structure of the course

I will dedicate as much time to the course as necessary. The material in the course is closely related to my research and teaching interests and I intend to make this course a fun and productive experience for you.

a. Lectures

Research in Psychology has demonstrated that a central element in the learning process is active participation by the learner. I understand lectures can promote passive observation rather than active participation. Therefore, to promote active participation, my lectures will generally include:

- i. Presentation of technical material in which students participate in the analysis,
- ii. Discussion of the implications for the real world, and
- iii. The opportunity for students to work in teams and do practice problems related to the material we cover in the lectures.

The lectures will be more fun and productive if you have read the material ahead of time and come to class prepared to contribute to the discussion.

b. Grades

Your grade for the course will be determined by your performance in the assignments and examinations.

i. Examinations

There will be THREE examinations during the semester. Your performance on each examination will determine 20% of your grade. The examinations will generally consist of questions and problems similar to the problems presented

in class or in the assignments. I will provide you with more information about the examinations later in the course

ii. Assignments

A number of online assignments will be distributed during the semester. There will be HOMEWORK assignments and QUIZ assignments:

- i. HOMEWORK assignments: Your performance on the homework assignments will determine 20% of your grade. The homework assignments will consist mostly of numerical and graphical questions.
- ii. QUIZ assignments: Your performance on the quiz assignments will determine 20% of your grade. The quiz assignments will consist of multiple-choice questions.

iii. Attendance

You are required to attend and participate in class because attendance and participation are essential if you want to do well in this class. For instance, I may cover material not contained in the textbook but that I may include in the homework assignments and examinations. Finally, if you have to miss class, make sure you talk to me or your classmates about the material you missed.

Your grade for the class will be computed based on your overall performance using the standard scale:

Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade *only when* **all** *of the following conditions are met*: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not

satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the <u>Registrar's Form Library</u>.

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
