Course Overview: The purpose of this course is to provide students with opportunities to share and report progress on achievements or challenges of learning tasks in their Field Practicums. This includes the use of both empirical knowledge and reflection of practice-based skills such as engagement, assessment, intervention, and evaluation in micro and macro environments. This course provides students with the information necessary to begin to understand and successfully manage the personal, educational, and professional processes that are part of generalist education and professional practice.

Description of Course Content: This course will explore ethical issues, dilemmas, problem-solving, and skill acquisition in Field Practicum, providing both peer and instructor support and feedback. The course will prepare students for their practicum, help them understand how the practicum is related to other components of the foundation curriculum, and guide them through an initial process of integration of theory and practice. Students will be introduced to social work core competencies and practice behaviors.

Descriptions of Assignments:

Journal Entries (60 Points)

Students will submit six (6) journal entries (10 points each), utilizing the prompts provided by the instructor. Each journal entry should demonstrate both reflection and critical thinking skills. Topics for the journals are ethics, resource gaps, client interaction, ADEI in social work, and macro skill sets. Supplemental resources such as articles and podcasts will be posted to aid students in their reflection.

Synchronistic Meetings (30 Points)

Each student will attend **at least two synchronistic** meetings to process events occurring in field and/or to provide support to their field practicum peers. **The first synchronistic meeting is required.** Students are encouraged to attend more, if they are able and if they find it beneficial. **These meetings can count toward student's required 420 practicum hours.**

Seminar Confidentiality Agreement (10 Points)

To encourage ethical practices in Field, Students are required to complete the Seminar Confidentiality agreement at the start of the semester. This confidentiality agreement will cover both Seminar I and Seminar II.

All written assignments will be due on the date listed on the course schedule.

Withdrawing from Class

Students may withdraw (drop) from this course using the Withdrawal Portal. Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average. The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If

a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the 08/2024 rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the <u>Registrar's Form Library</u>.

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
