Demographic Profile

The population in Red River County, Texas was 11,627 per American Community Survey data for 2018-2022. The region has a civilian labor force of 4,521 with a participation rate of 47.2%. Of individuals 25 to 64 in Red River County, Texas, 12.1% have a bachelor's degree or higher which compares with 35.8% in the nation. The median household income in Red River County, Texas is \$44,583 and the median house value is \$113,600.



About This Report

Unemployment Rate

The unemployment rate for Red River County, Texas was 4.6% as of November 2024. The regional unemployment rate was higher than the national rate of 4.0%. One year earlier, in November 2023, the unemployment rate in Red River County, Texas was 4.0%.




Unemployment Rate for Red River County, Texas

About This Report

Wage Trends

The average worker in Red River County, Texas earned annual wages of \$41,044 as of 2024Q2. Average annual wages per worker decreased 1.5% in the region over the preceding four quarters. For comparison purposes, annual average wages were \$72,405 in the nation as of 2024Q2.



Annual average wages per worker data are derived from the Quarterly Census of Employment and Wages, provided by the Bureau of Labor Statistics and imputed where necessary. Data are updated through 2024Q1 with preliminary estimates updated to 2024Q2.

About This Report

Cost of Living Index

The Cost of Living Index estimates the relative price levels for consumer goods and services. When applied to wages and salaries, the result is a measure of relative purchasing power. The cost of living is 11.1% lower in Red River County, Texas than the U.S. average.

About This Report

Occupation Snapshot

The largest major occupation group in Red River County, Texas is Management Occupations, employing 629 workers. The next-largest occupation groups in the region are Healthcare Support Occupations (305 workers) and Office and Administrative Support Occupations (300). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Farming, Fishing, and Forestry Occupations (LQ = 7.64), Management Occupations (2.32), and Healthcare Support Occupations (1.89).

Occupation groups in Red River County, Texas with the highest average wages per worker are Legal Occupations (\$107,300), Management Occupations (\$85,800), and Computer and Mathematical Occupations (\$85,400). The unemployment rate in the region varied among the major groups from 1.4% among Management Occupations to 8.2% among Transportation and Material Moving Occupations.

Over the next 1 year, the fastest growing occupation group in Red River County, Texas is expected to be Healthcare Support Occupations with a +2.1% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Healthcare Support Occupations (+6 jobs) and Management Occupations (+2). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Management Occupations (59 jobs) and Healthcare Support Occupations (44).



About This Report

Industry Clusters

A cluster is a geographic concentration of interrelated industries or occupations. The industry cluster in Red River County, Texas with the highest relative concentration is Agricultural with a location quotient of 19.99. This cluster employs 635 workers in the region with an average wage of \$33,934. Employment in the Agricultural cluster is projected to expand in the region about 0.0% per year over the next ten years.




Industry Clusters for Red River County, Texas as of 2024Q2

About This Report

Education Levels

Expected growth rates for occupations vary by the education and training required. While all employment in Red River County, Texas is projected to grow 0.6% over the next ten years, occupations typically requiring a postgraduate degree are expected to grow 1.0% per year, those requiring a bachelor's degree are forecast to grow 1.0% per year, and occupations typically needing a 2-year degree or certificate are expected to grow 1.0% per year.




Annual Average Projected Job Growth by Education Levels

About This Report

Gross Domestic Product

Gross Domestic Product (GDP) is the total value of goods and services produced by a region. In 2023, nominal GDP in Red River County, Texas expanded 4.3%. This follows growth of 3.5% in 2022. As of 2023, total GDP in Red River County, Texas was \$309,635,000.


Of the sectors in Red River County, Texas, Agriculture, Forestry, Fishing and Hunting contributed the largest portion of GDP in 2023, \$51,133,000 The next-largest contributions came from Wholesale Trade (\$36,533,000); Manufacturing (\$36,170,000); and Construction (\$35,743,000).
