#### **Course Description**

This course is designed for Ph.D. students and covers the foundations of organizational change and development research. This advanced doctoral seminar will introduce learners to the field of Organization Development (OD), an area of practice and research in Human Resource Development (HRD). OD is concerned with creating, managing, and sustaining system-wide planned change in organizations using education and social science knowledge and practices to improve organizational, group, and individual functioning and effectiveness. Learners will be exposed to the history, philosophies, theories, techniques, and applications of OD through readings, in-class discussions, case activities/publishing, self-reflection exercises, and guest scholars.

### **Learning Objectives**

The objective of this course is to develop your knowledge in the following areas:

- Develop an understanding of the major theoretical foundations and principles of organizational development (OD) and organizational change (OC);
- Develop and understanding on the relationship between the role of culture, leadership, and management in creating sustainable performance synergy through OD/OC processes;
- Critique and suggest solutions through case studies for effective OD/OC processes;
- Examine theoretical approaches on leadership in facilitating effective OD/OC processes.
- Increase leadership competency for effective OD/OC processes.

- Use scholarly (academic) voice to express your research and define the intellectual boundaries of your work;
- Demonstrate a clear focus in your work on the research phenomenon under investigation—be prepared to articulate your work at any time;
- Write clearly and concisely using APA 7th formatting guidelines;
- Retrieve articles using the various research repositories including the UT Tyler online library system, ProQuest, Google Scholar, etc;
- Cite sources, giving credit to where you obtain information—ALWAYS!
- Engage in academic discourse with others to understand their perspective and demonstrate scholarly professionalism when communicating;
- Make the commitment to spend the hours needed to successfully leave this course competent in the outlined learning objective.

#### **Course Requirements**

This course focuses on both theoretical foundation and applications of OD/OC. Students will be evaluated based on the quality of their work. As this is a doctoral seminar, the level of quality must be consistent with Ph.D. scholarly expectations. Additional information will be given regarding each assignment before the due date.

Students will be evaluated based on the quantity, quality, and timeliness of the following efforts.

- Attendance and active participation in classes, including all online and classroom discussions and activities;
- Quality writing assignments;
- Clear and professional class presentations.

#### Class Deliverables for HRD 6388

## 1. Article Review (15 points)

- a. This is an individual assignment that is due (posted to Canvas) by 1 pm on February 4, 2022. Each learner will choose an article from the journal *Perception* within the past 5 years and relate the importance of the article to OD/OC through a theoretical framework. Each learner will prepare a 1200-1300 word paper. Include on a separate Title page:
  - i. A complete citation of the chosen article;
  - ii. A not-to-exceed 100-word abstract of your paper (in your own words and not copied from the article (separate from the four-page paper).
- 2. Group Case Study Presentation (15 points)
  - a. Groups (consisting of 2 learners) will each present a case study from <a href="https://helpfulprofessor.com/psychology-experiments-and-case-studies/">https://helpfulprofessor.com/psychology-experiments-and-case-studies/</a>—a context not normally associated with HRD. Learners will be expected to extract OD/OC principles from the (non-HRD) case study and illustrate potential application to HRD. Include in your presentation a summary of your case and a decision template in your presentation. Coordinate with your classmates and do not duplicate case studies—you may choose a case not listed in the above link, however, make sure its tenets are applicable to the spirit of the assignment.
- 3. Poster Presentation with Abstract (10 points)
  - a. This is an individual assignment. Each learner will develop and present a 7-8 minute poster presentation that clearly outlines their research for the Final Project. This poster should include:
    - i. Rational for the research
    - ii. Statement of the problem
    - iii. Theoretical underpinning
    - iv. Conceptual framework
    - v. Implications for OD/OC
    - vi. Implications for HRD
  - b. A 750-word written abstract of the poster
- 4. In-Class OD/OC Conference Submission (50 points).
  - a. This is an individual assignment. Each learner will develop a 5000-6000 word doubled spaced research paper on any facet of OD/OC that interests you. Describe the phenomenon of interest, why it is important to the OD/OC field, a summary of relevant literature that addresses the topic, and an agenda for future research that specifies at least three directions for future consideration. Use APA 7th formatting and citations. This paper is due by April 29, 2023, at 11:59pm.
  - b. Each learner will prepare a 10 minute oral presentation of their paper and present it on the final day of class.
- 5. Class Participation/Discussion (10 points)

## Make-Up Work and Late Work

Make-Up work is allowed with a medical/official university business excuse without proper documentation. Otherwise, late work **will not** be accepted unless approved by the instructor ahead of time for special cases.

## **Class Meeting Attendance**

Attending all five class sessions demonstrates the learner's personal commitment to learning. Therefore, physical attendance is expected for the accomplishment of course objectives. The facilitator recognizes that learners may have special issues and responsibilities that may impact physical attendance. If physical absences occur, the learner is responsible for contacting the facilitator in advance so that adjustments can be made to the instructional activities planned for a specific session. With approval from the instructor and the department chair, the learner may participate virtually. The instructor may provide limited access to the class through Zoom. However, it is the learner's responsibility to arrange with an in-class peer to provide virtual access to the class to ensure the quality of classroom learning. The learner is responsible for all work that is missed due to their absence from any class meeting, or portion thereof. It should be expected that physical absence from classes for reasons other than documented illnesses, emergencies, or other matters that prohibit the learner from traveling due to COVID restrictions may affect the final course grade. Excused absences for religious holy days or active military services are also permitted according to the policies outlined in the UT Tyler Graduate Handbook. One unexcused absence may result in a final grade reduced by one letter grade. ## **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

#### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
