Course Description

This course is an advanced doctoral seminar that introduces foundations of talent management and development research. Emphasis is placed on research perspectives, methodology, and theoretical frameworks employed by HRD scholars on career development and firm performance through the discipline of talent management and development. Students will be exposed to research philosophies, theories, techniques, and applications through readings, reviews, in-class discussions, writing exercises, and other scholarly works.

- Developed an understanding of the relationship between talent management and development and implications for HRD research;
- Gained a better understanding of methods to conceptualizing emerging research on talent management and development;
- Increased overall research competency for potential scholarship opportunities in talent management and development.

- Demonstrate a clear focus in your work on the research phenomenon under investigation—be prepared to articulate your work at any time;
- Write clearly and concisely using APA 7th formatting guidelines;
- Retrieve articles using the various research repositories including the UT Tyler online library system, ProQuest, Google Scholar, etc.;
- Cite sources, giving credit to where you obtain information—ALWAYS!
- Engage in academic discourse with others to understand their perspective and demonstrate scholarly professionalism when communicating;
- Make the commitment to spend the hours needed to successfully leave this course competent in the outlined learning objective.

Course Requirements

This course focuses on both theoretical foundation and research implications of talent management and development. As this is a doctoral seminar, the level of quality must be consistent with Ph.D. scholarly expectations. **Additional information will be given regarding each assignment before the due date.**

Students will be evaluated based on the quantity, quality, and timeliness of the following efforts.

- Attendance and active participation in classes, including all online and classroom discussions and activities;
- Writing assignments;
- Clear and professional class presentations.

Class Deliverables

1. Article Review Paper (10 points) and Oral Presentation (5 points)

Due by 1:00pm September 23, 2023 (submit to Canvas before class)

- a. This is an individual assignment. Each learner will choose an article from a journal listed on the HRD section of the Soules College of Business Journal List. The article must have a research focus on some aspect of talent management and development. Each learner will prepare a review paper and an oral presentation based upon their chosen article.
- b. The review paper must include:
 - i. A complete APA 7 citation of the chosen article;
 - ii. A not-to-exceed 100-word abstract of the article (in your own words, not copied from the article);
 - iii. A 1500-2000 word overview of the article that incorporates implications for HRD research and explicates your related thoughts on human sociality in the workplace.
- c. The oral presentation must include:
 - i. A 5-7 minute overview of the article that incorporates implications for HRD research and explicates your related thoughts for discussion on human sociality in the workplace.

2. Article Review Paper (10 points) and Oral Presentation (5 points)

Due by 1:00pm October 14, 2023 (submit to Canvas before class)

- a. This is an individual assignment. Each learner will choose an article from a list of psychology journals (https://en.wikipedia.org/wiki/List_of_psychology_journals). Each learner will prepare a review paper and an oral presentation based upon their chosen article.
- b. The review paper must include:
 - i. A complete APA 7 citation of the chosen article;
 - ii. A not-to-exceed 100-word abstract of the article (in your own words, not copied from the article);
 - iii. A 1500-2000 word overview of the article that incorporates implications for talent management and development and explicates your related thoughts on human sociality in the workplace.
- c. The oral presentation must include:
 - i. A 5-7 minute overview of the article that incorporates implications for talent management and development and explicates thoughts for discussion on human sociality in the workplace.

3. Poster Presentation with Abstract (10 points)

Due by 1:00pm November 4, 2023 (submit to Canvas before class)

- a. This is an individual assignment. Each learner will develop and present a 7-10 minute poster presentation that clearly outlines their research for the Final Project. This poster should include:
 - i. Rationale for the research
 - ii. Statement of the problem
 - iii. Theoretical underpinning
 - iv. Conceptual framework
 - v. Implications for talent management and development
 - vi. Implications for HRD
- b. A not-to-exceed 750-word written abstract of the poster.

4. Final Project-Paper (30 points) and Oral Presentation (20 points)

Paper is due by 11:59pm December 9, 2022 (submit to Canvas)

Presentation is due December 2, 2023 (in-class)

- a. This is a semester long individual project. To successfully complete the project, you will need to start early in the semester with the following steps.
- b. Each learner will identify a talent management and development research problem of their interest. Then each learner will prepare a 4000-5000 word paper that includes:
 - i. Develop a rationale for the research;
 - ii. Provide a statement of the problem;
 - iii. Formulate a theoretical underpinning;
 - iv. Formulate a conceptual framework;
 - v. Provide implications for talent management and development;
 - vi. Provide implications for HRD.
- c. Each learner will prepare a 20 minute oral presentation of their paper and present it to class.

5. Class Participation (10 points)—this is not a given, relevant level discourse is expected each class session.

Make-Up Work and Late Work

Make-Up work is allowed with a medical/official university business excuse with proper documentation. Otherwise, late work **will not** be accepted unless approved by the instructor ahead of time for special cases.

Class Meeting Attendance

Attending all five class sessions demonstrates the learner's personal commitment to learning. Therefore, physical attendance is expected for the accomplishment of course objectives. The facilitator recognizes that learners may have special issues and responsibilities that may impact physical attendance. If physical absences occur, the learner is responsible for contacting the facilitator in advance so that adjustments can be made to the instructional activities planned for a specific session. With approval from the instructor and the department chair, the learner may participate virtually. The instructor may provide limited access to the class through Zoom. However, it is the learner's responsibility to arrange with an in-class peer to provide virtual access to the class to ensure the quality of classroom learning. The learner is responsible for all work that is missed due to their absence from any class meeting, or portion thereof. It should be expected that physical absence from classes for reasons other than documented illnesses, emergencies, or other matters that prohibit the learner from traveling due to COVID restrictions may affect the final course grade. Excused absences for religious holy days or active military services are also permitted according to the policies outlined in the UT Tyler Graduate Handbook. One unexcused absence may result in a final grade reduced by one letter grade. Two or more unexcused absences from class will likely result in a grade of Incomplete (I) requiring the student to retake the course.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a “W” grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

 - j. paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
 - k. falsifying research data, laboratory reports, and/or other academic work offered for credit;
 - l. taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
