This course is an opportunity for development of clear and persuasive business communication skills, study of interpersonal communication channels in internal and external environments, and experience in writing business letters, reports, and other written communications.

**COURSE OBJECTIVES:**

*Knowledge objectives of this course include:*

1. Prepare business documents that are focused, well-organized and mechanically correct.
2. Create accurate, clear, concise audience-centered messages – verbally and in writing.
3. Use informal and formal research techniques to gather information
4. Effectively incorporate feedback to improve business communication skills.
5. Understand the importance of making ethical communication decisions and the need for personal accountability in all aspects of business communication

6. Understand contemporary business culture in order to adapt communication messages
7. Gain awareness of the ethical implications of business decisions in international and domestic settings
8. Utilize critical thinking and problem-solving skills to create responsible, effective, and sustainable solutions to global business problems

*Competencies to be demonstrated in this course include:*

1. Communication Skills
  - a. Written Communication: Students are required to complete various writing assignments, including e-mail messages, memos, informal reports, and formal reports. All written work should be referenced in APA citation style when required by the instructor.
  - b. Oral Communication: Students are required to complete speaking assignments, including an informative speech and a group presentation.
  - c. Nonverbal Communication: Students will learn to recognize and use effective nonverbal cues when speaking and listening.
  - d. Oral Communication: Students are required to complete speaking assignments.
2. Ethical Issues
  - a. Ethical Communication: Students will learn ethical communication practices for use in the classroom and in the workforce.
  - b. Academic Integrity: Students will be held to a very high standard in regard to personal integrity, intellectual honesty, and ethical behavior. University standards regulating academic integrity are strictly enforced.
3. Personal Accountability for Achievement
  - a. Learning Climate: The classroom will be a positive and productive learning environment for all students based upon open communication, respect for diverse backgrounds, ideas and opinions, as well as non-discrimination.
  - b. Deadlines/Late Policy: All assignments and exams must be completed by the assigned due dates, but I will accept late work up to 24 hours after the original due date with a **30% penalty**. After the 24 hours grace period, the student will receive a zero. No make-ups or extensions will be permitted unless the student obtains permission from the instructor *prior* to the due date and has a *verifiable* excuse. Missing an exam/quiz results in a zero.
  - c. Discussion of Graded Assignments: Success in this course requires thoughtful self-evaluation of performance. When students discuss grades with the instructor, they must be prepared to make a thoughtful case regarding the evaluation. Arguments must be related to the assignment as presented and based on how it compares with the evaluation criteria (not on how it compares to assignments in another course or a fellow classmate's grade). **Discussions about assignments should occur within one week of receiving evaluation.**
  - d. Classroom Courtesies:
    - i. Electronic Devices: No electronic devices of any kind are allowed in class (including earbuds, cell phones, tablets, laptops, etc.). After one warning, the student will be asked to leave class for the day. In an emergency, please leave the classroom to use your cell phone.
    - ii. Eating and drinking: You may eat during class if you bring enough for everyone, especially your instructor. You may drink nonalcoholic beverages during class if the container has a lid.
    - iii. Tobacco: Tobacco consumption of any kind is not permitted during class (please see University guidelines below).
  - e. Attendance: **Attendance is mandatory in this course.** Because this is a skills-based course, attending every class session is critical. Being absent will deprive students of valuable class discussions.

- f. Tardiness: Students are expected to arrive to class on time every day. If a student is late or leaves early, he/she won't receive the five points for attendance that day. As soon as the lecture begins for the day, the student will be considered late.
- g. Participation: The quality of a student's participation in this course will greatly influence the quality of his or her learning. Students should:
  - i. Attend class (physical presence is necessary, but not sufficient)
  - ii. Demonstrate that assigned materials have been read
  - iii. Complete all assignments in accordance with deadlines
  - iv. Ask thoughtful questions that extend class discussion
  - v. Contribute "real life" examples to demonstrate theory
  - vi. Express respect for all classmates and the instructor.

*Outcomes for students to successfully complete this course include:*

1. Creation of accurate, concise, and audience-centered messages in the form of written correspondence, written reports, and memos
2. Demonstration of informal and formal research techniques through accurately obtained and cited report and presentation material
3. Effective incorporation of feedback demonstrated through writing revisions, speech delivery improvement, and assignment self-reflection
4. Development of communication etiquette for use in the workplace
5. Understanding of contemporary business culture demonstrated through research and practical demonstration in writing and speaking assignments.

**EVALUATION:**

Grades are determined on a straight percentage scale based on the number of points earned out of a maximum of 1600 points. **There will be no further rounding or curving of grades.**

**Important note: The chapter writing assignments, the speech, and the PowerPoint are mandatory and must be completed in order to pass the course.**

## **GRADE REPLACEMENT/FORGIVENESS AND CENSUS DATE**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated (For spring the Census Date is January 25.). Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (Jan. 25) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

## **STATE-MANDATED COURSE DROP POLICY**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the 12th day of class (See Schedule of Classes for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Registrar's Office and must be accompanied by documentation of the extenuating circumstance. Please contact the Registrar's Office if you have any questions.

### **STUDENT STANDARDS OF ACADEMIC CONDUCT**

- A. "Cheating" includes, but is not limited to:
- copying from another student's test paper;
  - using, during a test, materials not authorized by the person giving the test;
  - failure to comply with instructions given by the person administering the test;
  - possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes." The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
  - using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
  - collaborating with or seeking aid from another student during a test or other assignment without authority;
  - discussing the contents of an examination with another student who will take the examination;

- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructor has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
  - substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
  - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution, or computer program;
  - falsifying research data, laboratory reports, and/or other academic work offered for credit;
  - taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
  - misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- B. “Plagiarism” includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another’s work and the submission of it as one’s own academic work offered for credit.
- C. “Collusion” includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
