Important Information for Success in MANA 4335

- 1. <u>Communication:</u> If you do not understand a concept, assignment, feedback I give, or a grade, please ask! If you are having troubles with work or personal issues that are impeding your success in this class, let me know so we can work together for a successful semester.
- 2. <u>Modules:</u> This course is divided into modules. Each content module covers two chapters from the textbook. In each module, you will have an assignment and a video post. After four chapters (two modules), there is a quiz module. The quiz modules are only open for one week. Even though you have two weeks for assignments, don't procrastinate! The quality of your work will be reflected in your grade.
- 3. Format for assignments:
 - Name and date at the top right of all submitted documents
 - 12-point font
 - Citations, when necessary, listed on a separate page at the end of the assignment. All citations should be in APA Style. For more information view www.apastyle.org or https://owl.perdue.edu
- 4. <u>Assignments:</u> I will accept assignments one day past the due date and assess a ten-point late penalty. After the one-day late acceptance day, assignments will not be accepted and a zero will be given for the assignment. For example, if a 50-point assignment is due on Sunday, but I do not submit my work until Monday, the highest grade I can receive is a 40. If I wait until Tuesday, it is too late. I will receive a zero for the assignment.
- 5. <u>Plagiarism:</u> I know there is a wealth of information on the Internet, and you can find an answer to most questions. I love for you to use outside resources, but they should be used in addition to the textbook and information I give to form your own ideas and answers. You should always document the sources you use to formulate your answers. If you do not document your sources and use your own words (plagiarize) you will receive a zero for the assignment or discussion post.
- 6. <u>Video Posts:</u> Video posts will be created in Flipgrid. Each post is worth 25 points. There are no late posts accepted. These are only posts by you. Replies to other students are extra credit.
- 7. <u>Discussion Boards:</u> Discussion boards are a part of this course. When a module includes a discussion board, each student must post an initial response to the given question or scenario no later than the <u>first Sunday</u> in the current module. A response to class members' posts must then be made no later than the second Sunday of the current module. For late initial posts, there will be a five-point penalty per day late. No posts or replies will be accepted for credit when the discussion board closes at the end of the module.
- 8. **Quizzes:** Each quiz will cover the textbook material for the specified chapters as well as any additional content I have given you in Canvas.
- 9. Extra Credit: You are not required to reply to your classmates' video posts. If you choose to reply, I will give up to 5 points of extra credit (total) for each module. The points will be dependent on the content and quality of your reply(ies). This means I do not give extra credit for telling a classmate you agree, and they did a great job.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census

Date) • Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)

- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
