1. Attendance & Participation:

- Yes, you are required to come to all class meetings and participate! A portion of your grade comes from in-class participation. If you miss class, you will miss learning, and you may miss earning points toward your final grade. Missed in-class participation points cannot be made up.
- I understand emergencies or other unexpected circumstances arise. If this is the case, email me as soon as possible so we can discuss what you missed.

2. Format for assignments:

- Citations, when necessary, listed on a separate page at the end of the assignment. All citations should be in APA Style. For more information view <u>www.apastyle.org</u> or <u>https://owl.perdue.edu</u>
- Assignments are required to be in Word document format, not pdf
- Late Work Policy for Assignments: I will accept assignments one day past the due date and assess a twenty-point (20) late penalty. After the one-day late acceptance day, assignments will not be accepted and a zero will be given for the assignment.
- <u>GMetrix:</u> GMetrix is a computer application that will help improve your skills in Excel. These skills will be used to analyze data (analytical thinking) during the semester. If you do not score a minimum 700 on the GMetrix test by the end of the semester, the highest grade you can achieve in the course is a C.
- 5. Plagiarism: I know there is a wealth of information on the Internet, and you can find an answer to most questions. I love for you to use outside resources, but they should be used in addition to the textbook and information I give to form your own ideas and answers. You should always document the sources you use to formulate your answers. If you do not document your sources and use your own words (plagiarize) you will receive a zero for the assignment or discussion post.
- 6. <u>AI Use:</u> AI can be a wonderful tool but should be used as just that a tool. You are welcome to use AI to help generate ideas, but I caution you in doing this. Using AI can sometimes stifle your own ideas, leading you to lean too heavily on AI for your assignment submission. I will not accept assignments or discussion posts that have been generated by AI, then copied, pasted, and submitted. This is considered plagiarism. In addition to reading your submissions, I use the AI checker that is provided in Canvas. If I believe your assignment is an AI generated submission, you will be required to meet with me to discuss and answer some questions about the submission and chapter content.

COURSE OBJECTIVES

- 1. Apply the elements of reasoning and standards of critical thinking to think through concepts and issues. Some applications in this class include:
 - a. Creating well-written answers and opinions about a variety of topics using critical thinking skills and models
 - b. Detecting errors in reasoning and explaining how the reasoning is in error
 - c. Evaluating evidence and making appropriate inferences from that evidence
 - d. Providing thoughtful feedback to peers and participating effectively in group collaborative learning activities
- 2. Demonstrate the ability to analyze and interpret data
- 3. Demonstrate the decision making and problem-solving skills needed in a business environment
- 4. Cite all sources used in your class work correctly using APA style. Meeting this objective will ensure that:
 - a. it is clear what thoughts and ideas in your work are the results of your own critical and analytical thinking
 - b. readers can use your citations to find/review the original sources of ideas and there will be no plagiarism in your class submissions.

EVALUATION:

There are 1,000 possible points to earn in this course. You start at 0 and earn your points by submitting assignments, participating in class, and completing all parts of the projects.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

• Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

• Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date) • Schedule adjustments (section changes, adding

- a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog.
