### **Course Description**

This course is designed to provide students with different perspectives on Organization Development at the individual, group, and organizational levels of analysis. Theoretical models will be studied, along with practitioner examples of organizations utilizing organization development interventions.

### **Learning Objectives**

Upon completion of this course, students should be able to:

- Develop an appreciation for OD as a core area of HRD practice, and an understanding of the theories, philosophies, and historical background of the OD field.
- Review and reflect on theories, philosophies, models, and methods related to OD as a profession.
- Identify and review the roles of internal and external OD practitioners in organizational change processes.
- Gain knowledge and expertise in selected areas of OD as a result of course projects and activities.
- Explore OD applications in a collaborative group setting.

### **Course Competencies**

1. Computer-Based Skills – the student will complete the final project in a word processing package that may include graphs, charts, spreadsheets, database manipulation.
2. Communication Skills – the student will exhibit a mastery of written skills through the final project.
3. Problem Solving (Critical Thinking) – the student will use conceptual thinking, quantitative/statistical skills, gathering and analyzing data, and creativity and innovation in the identification and completion of the research project.
4. Ethical Issues in Decision Making and Behavior – the student will understand and exhibit ethics through the data collection and presentation portions of this project.
5. Personal Accountability for Achievement – the student will complete the project at the time designated by the instructor.

## Course Requirements

This course focuses on both theoretical foundation and applications of organizational development. Students will be evaluated on the basis of the quantity, quality, and timeliness of the following efforts. **Additional information will be given regarding each assignment before the due date.**

#### **Animoto Introduction Video**

- Students will be required to make an Animoto introduction video lasting at least 60 seconds.
- Students will create an account at [www.animoto.com](http://www.animoto.com) by signing up. Once signed in, follow the directions and click “Create” to start making your video. Once completed, students will post a link to their video in their group discussion area.
- You may include words, pictures, and songs in your video. Be creative! What do you want your classmates to know about you? Show us who you are!
- Students may use an alternative video site if they would like. However, it will need to be at least 60 seconds with pictures.

#### **Group discussion, reading and online participation**

- During this class there will be 4 topics that I will introduce for discussion. Students are responsible for responding to the topic in a clear and thoughtful way. **Posts must be thorough with text examples and include at least 1 citation (APA 7<sup>th</sup> edition).**
- Initial posts will be due on Wednesday night at 11:59pm and are posted in the Tentative Schedule below.
- In addition to your post on the topic for discussion, you will be required to respond to at least two of your classmates. Response posts will be due Sunday night at 11:59pm and are posted in the Tentative Schedule below.
- Initial Posts must be 300 words. Response posts must be 100 words.
- **Late posts will not be accepted.**

## Quizzes

- Each quiz will have 20-30 questions and may contain True/False and multiple-choice questions. Questions in each quiz will cover content in the course book to reinforce key insights and information. You will have 90 minutes to take each quiz.
  - Quiz 1 will include content from chapters 1-4.
  - Quiz 2 will include content from chapters 5-8.
  - Quiz 3 will include content from chapters 9-12.
  - Quiz 4 will include content from chapters 13-15.
  - Quiz 5 will include content from chapters 16-19.

## Case Study Project Paper: Organizational Development

Objective: In this assignment, students will conduct an in-depth analysis of an organizational development case study based on information from a newspaper, magazine, or online article.

Incorporation of Theory: The paper should integrate relevant organizational development theories to analyze the chosen case. Discuss how these theories help explain the strategies or outcomes evident in the case study.

Structure:

- Begin with an introduction to the organization, providing context based on the article.
- Discuss the challenges or opportunities faced by the organization.
- Apply organizational development theories to analyze these challenges/opportunities and explain how they impacted the organization's decisions and outcomes.
- Conclude with key takeaways or lessons learned about effective organizational development practices.

Format Requirements:

- The paper should be between 3.5 and 4 pages long, written in Times New Roman, size 12, and double-spaced.
- Ensure proper citation in APA 7th edition format, so that the article and organization discussed can be easily identified.

## Plagiarism Policy:

In this course, the Unicheck plagiarism software will be used to evaluate the originality of submitted work. Adhering to academic integrity is crucial. The following guidelines will be enforced regarding plagiarism:

- Any paper found to have over 10% plagiarism (as reported by Unicheck) will be reduced by one letter grade.
- Any paper found to have over 15% plagiarism will receive no credit.

Ensure that all sources are properly cited in APA 7th edition format and remember to paraphrase where appropriate. This policy aims to promote ethical writing practices and the development of your original academic voice.

### Zoom Meeting(s) (optional)

Students will be provided with the opportunity to meet via Zoom every Tuesday evening at 7:00pm CST. The content of the meeting(s) will include discussion on chapter readings, assignments, and various other topics of student interest. The goal of the Zoom meeting(s) is to create dialog, answer questions, and keep you informed. The outcome of the meeting(s) will largely depend on student participation.

### Make-Up Work and Late Work

Make-Up work is allowed with a medical/official university business excuse without proper documentation. Otherwise, late work **will not** be accepted unless approved by the instructor ahead of time for special cases.

### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

1. Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
2. Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
3. Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
4. Being reinstated or re-enrolled in classes after being dropped for non-payment
5. Completing the process for tuition exemptions or waivers through Financial Aid

### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

  - d. possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
  - e. using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
  - f. collaborating with or seeking aid from another student during a test or other assignment without authority;
  - g. discussing the contents of an examination with another student who will take the examination;
  - h. divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
  - i. substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
  - j. paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
  - k. falsifying research data, laboratory reports, and/or other academic work offered for credit;
  - l. taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
  - m. misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- II. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- III. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- IV. All written work that is submitted will be subject to review by plagiarism software.
