**COURSE DESCRIPTION:** This course focuses on the mechanics of globalization and the mastery of business strategy, operation and practices from a global perspective. This includes the exploration of national differences in political economy, culture, ethics, and their implications in international management; the impact of trade policies on companies' international strategies and risks; the key choices managers have in internationalization strategy, organizational architecture, production, marketing and HRM, and how to integrate such choices into a global strategy. This course has immediate applications for managers in all areas of the firm, and in almost all industries.

**COURSE OBJECTIVES:** In accordance with the Soules College of Business Student Learning Objectives, this class addresses:

- #2. Recognize major managerial challenges such as the globalization of business, managing a cultural and ethnically diverse workplace, increasing interdependence among organizational units, intensifying competitive dynamics, and the escalating ethical responsibilities of managers.

- #6. Understand factors that influence individual, group, and corporate behavior and use this knowledge to improve individual and firm performance.
- #8. Understand how strategic decisions are influenced by and also help to create competitive dynamics within and between industries.
- #9. Recognize and access the impact of environmental factors in decision making, as well as develop conceptual skills
- #10. Improve written communication skills.

# Discussion Forums

# -- Participation Expectations:

The grading is comprised of two components, the initial post and responding posts. I will not penalize you in discussions for spelling or grammar errors. See the Rubric for Discussion Forum at bottom of syllabus.

#### **Initial Post:**

You must make your initial discussion posts no later than 11:55PM CST on Thursday of the online week. Initial posts made after Thursday will receive a 10% penalty for one day of lateness, 20% for two, and 30% for three days. Any initial discussion posts made after Sunday will receive no credit. This is like entering a work meeting late, wherein everyone has left the room.

# Responding Posts:

You must reply to at least two classmates no later than 11:55PM CST Sunday of the online week. Any response posts made after Sunday will receive no credit. This is like entering a work meeting late, wherein everyone has left the room. Regarding the discussion forum, I strive to develop your critical thinking and in addition, my effort is to post topics relevant to the course that encourage threaded conversation. In other words, I avoid questions that will elicit close-ended responses from you such as "I agree". Instead, open-ended topics that use phrases such as "Share your thoughts..." or "Based on our study of xyz, how ...?" will be used.

# --Evaluative Criteria:

Discussions are not a mutual admiration support session. Do not throw cream puff comments back and forth. Do not blow each other air kisses. Instead, it is an environment intended to foster critical thinking. I will evaluate your posts in terms of their meeting the following criteria.

# Do you:

- 1. Offer real-world examples/current events that relate to relevant non-text sources (e.g., magazines, newspapers, and journals)?
- 2. Offer textbook references?
- 3. Challenge each other?
- 4. Ask clarifying questions?
- 5. Point out other viewpoints?

#### Late Policy for Initial Post:

Three days of lateness are allowed. Initial discussion posts made after Thursday will receive a 10% penalty for one day of lateness, 20% for two, and 30% for three days. Any initial discussion posts made after Sunday will receive no credit. This is like entering a work meeting late, wherein everyone has left the room.

# Late Policy for Responding Posts:

Any post made after Sunday will receive no credit. This is like entering a work meeting late, wherein everyone has left the room.

During some modules, I may elect not to post a question for discussion. In this case, I will give all students full credit.

- --Late Policy: If you submit your case analysis on the Monday after the Sunday due date, your submission will receive an automatic 10% reduction. If submission is on Tuesday, the penalty is 20%, and on Wednesday, it is 30%. No submissions are allowed after Wednesday and earn a 0.
- --Required Email Subject Line Info for Case Analyses: When emailing your paper to me, the required email subject line information is: *Your Last Name, Course Name, Case I*. The penalty for not using this format: 2% points reduction. For example, type: *Doe, International Business, Case I*
- --Required Format for Case Analysis: A cover sheet is <u>not</u> required. The heading of the case should be *Your Name*, *Course Name*, *Case I (or Case II or Case III)*. *I will grade your* referencing/citing, grammar, spelling and style. See the Rubric for Written Work at the bottom of this syllabus.
- --Exact Assignment Parameters: You must answer <u>all</u> sections and use numbers and letters to indicate all sections. The penalty for not using this answer-labeling format of, e.g., 1, 2 or 3 and a, b, or c is an automatic 15% points reduction. The reason for this penalty is students often inadvertently bury their answers in a wordy array of sentences and paragraphs which makes it difficult for the instructor to grade the student's deliverable. I do not want to go on a hunting expedition for your answers. Thanks.

A quality paper/presentation will include:

- -Formatting which meets the University's required protocol (e.g., APA)
- -A formal introduction (unless the assignment asks for an executive summary or for an outline). The intromust include a statement that says: "this paper will address...." or "the following analysis will"
- -A conclusion which should be a compelling wrap-up, and share key 'ahhaas' or 'take aways'
- -Citations which are tied to references. References by themselves are not sufficient.

A quality paper/presentation will:

-Be written as though it will be submitted it to a busy executive in an organization. Visualize him/her reading it while in an airport-bound UBER vehicle. Therefore, enable the executive to find and follow points effortlessly by:

- -Organizing the essay in a way that follows the flow of topics found in the assignment (e.g., if the task asks for the analysis of points I, a, b, c and II, a, b, c, then your essay should follow this approach.
- -Using headings and/or subheadings to guide the busy executive in finding the various sections/topics

A quality paper/presentation will:

- -Be written as a formal essay using full sentences and paragraphs (except if an outline format is requested); Q & A format will not be used
- -Use only third person (i.e., do not use "I", "we", unless the statements being made describe your personal actions, direct experiences, or engagement
- -Refer to a firm, organization, or country as a single legal entity, use the singular form. For example, IBM is an "it", and not a "they".
- -Have no incorrect spelling (e.g., its vs. it's; effect vs. affect; loose vs. lose)
- -Feature good word usage / grammar (e.g., do not combine a singular subject w/ a plural verb)
- -Use consistent capitalization (e.g., upper and lower case will not be used randomly)
- -Be free of punctuation, grammatical, or style errors not mentioned above

A quality paper/presentation will:
