Course Description: Examines psychopathology and diagnosis. Attention given to the causes of abnormal behavior patterns, the labeling process, the impact of culture, psychiatric nomenclature, and treatment procedures. Biological, psychological, and social constructs in diagnosis will be emphasized.

Course Evaluation:

Course evaluation is based on performance on two examinations, a mid-term and a final examination. The final will be comprehensive. The mid-term examination will count 40% of the final grade. The final examination will count 50% of the grade. Participation and any in-class quizzes will count 10%. A description of each test will be provided several weeks prior to the test as a study guide. There will be no paper required. It is expected that you attend class and follow the readings.
