Course Catalog Description: A survey of historical and contemporary associative and cognitive learning theories, and related conditioning principles, as applied to human and nonhuman animals. Laboratory exercises and demonstrations illustrating learning and conditioning in animals and humans.

Student Learning Outcomes:

•describe the major parts of scientific theories, and explain how we can decide which theories are good and which are not

•describe the different research techniques that psychologists use to study human and animal behavior

- •explain the behavioral and cognitive approaches to studying learning and how they differ •apply the principles of habituation
- •compare classical and operant conditioning
- •apply various behavior decelerators to undesired behaviors

•discuss the disadvantages of punishment

- •apply factors that can affect the performance on reinforcement and punishment strategies
- •apply errorless learning and stimulus control theory
- •discuss observational learning techniques

Course Design:

This is an asynchronous online course. Asynchronous learning happens on your own schedule. **There is no online or in-campus meeting for this course**. You can access all course materials, including readings, videos, presentations, assignments and quizzes via Canvas and complete them on your own schedule. But please keep in mind that you must meet the expected deadlines for each activity.

This class is divided into five modules. Each module contains two chapters. For each chapter, there is a lecture recording, PowerPoint presentation, a video quiz and a chapter quiz. Lecture recordings and presentations may guide you while reading the chapter. Video quizzes will help you to see real life applications of the concepts and at the end of each chapter you will test your learning with the chapter quizzes. Each week on Monday the class will start a new module. Within the week, students will manage

their time to complete the required assignments that are assigned for the week by **Sunday at** 11:59 pm!

Please make sure you have logged into Canvas and reviewed the informational messages explaining the workings of this course. I will make course announcements weekly to help you keep track of what assignments are due and inform you of any important updates within the course.

Incomplete Grade Policy: If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in lieu of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all course work or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor; and (c) the student presents these reasons prior to the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average for a student. The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to complete all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has not been assigned within one year, then the Incomplete will be changed to an F, or to NC if the course was originally taken under the CR/NC grading basis. Grade Appeal Policy: - UT Tyler's Grade Appeal policy requires the completion of a Grade Appeal form for this action to take place. The grade appeal begins with the instructor of your course. If you do not agree with the decision of the instructor, you may then move your appeal to the department chair/school director for that course. If you are still dissatisfied with the decision of the chair/director, you may move the appeal to the Dean of the College offering that course who has the final decision.
