Welcome to 3340 Heat Transfer. This course will introduce the fundamentals and applications of various modes of heat transfer, i.e., conduction, convection, and radiation. Analysis of practical heat transfer processes will be conducted employing analytical methods and numerical techniques. Upon completion of this course, students will be able to apply the simple theory of steady-state heat conduction, external and internal flow convection to engineering applications and understand the design and principles of important types of heat exchangers.

Course Objectives:

1. Understand the three primary modes of heat transfer: conduction, convection and radiation
2. Apply the conservation of energy to basic heat transfer analysis.
3. Apply the heat conduction equation in one-dimensional and two-dimensional situations.
4. Understand the boundary-layer flow and heat transfer
5. Apply convective heat transfer correlations to external and internal flows.
6. Use energy balances combined with heat transfer and heat transfer coefficients to analyze and design heat exchangers.

Mode of delivery: This is a face-to-face course. Course assignments, such as homeworks and open-ended projects, will always be submitted online via Canvas.

1. The course has two prerequisites which must be completed successfully prior to taking this course:
 - ✓ CHEN 3301 (Thermodynamics)
 - ✓ CHEN 3310 (Fluid Mechanics)
2. The goal of our faculty is to be commonly available to you for assistance, so you are encouraged and expected to seek **additional instruction (AI)**. Take advantage of AI, it's FREE and really will help! There are several ways you can seek AI:
 - ✓ You are welcome to stop by the instructor's office at any time. However, for your own satisfaction, you can ensure the instructor is available at the office by using the following options:
 - ✓ Come to Office hours (**Tuesdays and Thursdays from 11:00 pm - 1:00 pm**). This is the time the instructor has set aside to answer your questions;
 - ✓ E-mail or call the instructor to set up a mutually agreeable time to meet with the instructor,
 - ✓ E-mail your questions to the instructor (this is the least preferred option because of the limited effectiveness of e-mail communication), but it is acceptable if other options are not possible.
3. Classroom Procedures:
 - a. Bring study notes, **textbooks**, note-taking material, and calculator to every class. You may not borrow or exchange calculators during graded events. If your calculator fails during a graded exercise, I am not responsible to furnish a substitute. Class preparation is your individual responsibility.
 - b. *Textbooks:*
Theodore L. Bergman, Adrienne S. Lavine, Fundamentals of Heat and Mass Transfer, 8th Edition (Wiley).
 - c. *Recitations:*

A portion of certain lectures will be used for recitation sessions. These will be the students' opportunity to practice problem-solving skills applying the concepts learned in lectures. These skills will be needed for solving homework, quizzes and exam problems. Please bring your textbook for the recitation sessions.

4. Evaluations:

- a. *ACADEMIC DISHONESTY*: Representation of other's work as your own will not be tolerated. Cheating on examinations, quizzes, and homework and the false representation of work will be interpreted as academic dishonesty. Academic dishonesty will be subject to disciplinary action as outlined by the UT Tyler Student Guide on Conduct and Discipline.
- b. *Homeworks*: A set of homework problems will be assigned approximately every two weeks (there will be seven homework assignments during the semester). All homework is mandatory and becomes part of your grade. As an engineer your goal is to make a clear, logical, and professional presentation of your work, which is both accurate and correct. As such, both the presentation and the accuracy of your work is important, and both will be graded. It is critical that you show all of your work and leave "foot prints" so that it can be easily followed. No guess work should be required to see what you did. You are encouraged to work in groups, but the work that you turn in should be your own.
- c. *Late submissions*: Late homework will receive the following penalties:
 1. 0-24 hours late a deduction of 25% of the earned grade
 2. 24-48 hours late a deduction of 50% of the earned grade
 3. More than 48 hours late No credit.

Obviously, there are circumstances that will occur and make a timely submission impossible, and I will work with you when and if they occur.

All homework on this course must be properly documented. As you are having your work reviewed it is likely that you might receive help from your classmates, just simply document it. Information from the course textbooks (equations and outlines of procedures), class notes, or me is considered immediately available to all students and need not be acknowledged or documented with one exception. **YOU ARE REQUIRED TO ACKNOWLEDGE AND DOCUMENT ALL OTHER ASSISTANCE AND REFERENCES USED.** Documentation will be accomplished in accordance with any manual for writing, footnote or endnote, for papers, but for written homework, just place the documentation right at the point you received help using "Who and what" assistance.

- d. *Quizzes*: There will be four quizzes on scheduled dates during the semester. ***Quizzes will likely include problems from previous homework assignments and/or recitations.***
- e. *Participation grade*: Students are expected to be engaged in class and outside of the class. The instructor will assign a participation grade (from 0 to 6) to each student based on the following observations:
 - 1) Attendance in class and punctuality;
 - 2) Level of participation in class, asking questions about the material and answering questions from the instructor;
 - 3) Engagement in recitation sessions, demonstrating initiative to work on problems, and actively participating in the discussions;
 - 4) Asking questions outside class: after class, during office hours, and by e-mail.
- f. *Mid-Term Exams and Final Exam*: There will be one Midterm Exam and one Final exam. The Midterm will be one hour and twenty minutes and the Final will be two hours long. The dates for Exams are included in the course schedule. Official reasons for missing an exam are outlined in the "Student Handbook". You are required to take a make-up Exam, regardless of your reason for missing the scheduled Exam. Report any conflict to me as soon as possible prior to the Exam. You can use a **TI-30 calculator** (or FE equivalent), and ***you can bring one sheet with notes*** for each Exam.
- g. *Project*: At some point in the semester, students will be required to work on an assigned project. More details and requirements will be posted through Canvas. The project will be graded based on the report (3 points)

and oral presentation (3 points). You are encouraged to work in groups of two students. Only one report from each group is necessary. The contribution from each student should be clearly mentioned in the project report. Each student is required to present some portion in the oral project presentation.

5. Grading:

Grades will be based entirely on the student’s demonstrated ability to develop detailed, neat, organized, and correct solutions to the problems presented. Correct answers accompanied by incorrect, incomplete, or untidy solutions may receive no credit.

This will require me to make a copy of your work, keep your original and return a copy of the graded work to you. I will not draw attention as to what level of work you accomplished.

7. Assigned readings:

The class schedule will include assigned reading for every lecture. Students who read the corresponding sections of the book *before each class* will certainly make the most of the lectures, so this is highly recommended. In addition, the instructor will periodically post the lecture notes on the course website. Doing the assigned reading prior to class will help you to understand the material presented during the instruction and will fill in gaps for things we do not cover (***I will not cover everything***). It will also make you more familiar with terms and concepts to be covered.

Grade Replacement/Forgiveness and Census Date Policies - Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated.
