Welcome to CHEN 4330 – Process Control and Safety. This course will discuss the techniques and statistical tools that deal with the mechanisms and algorithms for controlling or automating a chemical process for effective and safe operation. Students will practice control methodologies to maintain operational conditions at set points, and to transition a process from one operational condition to another. They will also learn to identify safety hazards and apply Safety Management. Students successfully completing the course will be able to identify relevant process parameters, hazardous conditions, select and apply control methods to obtain desired outputs for a given set of inputs.

CHEN 4330 Process Control and Safety Course Objectives:

1. Use dynamic models to properly describe chemical processes
2. Solve Laplace transforms – understand t and s domains
3. Use transfer functions to perform calculations involving process inputs and outputs
4. Model responses of 1st and 2nd order processes
5. Explain features of feedback controllers
6. Design and analyze closed-loop control systems – block diagram reduction
7. Make recommendations of corrective actions after identification of safety hazards in a process

The course has one prerequisite which must be completed successfully prior to taking this course: MATH 3305 Differential Equations.

1. The goal of our faculty is to be commonly available to you for assistance, so you are encouraged and expected to seek supplemental instruction. Take advantage of supplemental instruction, it's FREE and really will help! There are several ways you can seek it:

2. Classroom Procedures:

- a. Bring study notes, **textbooks**, note-taking material, and calculator to every class. You may not borrow or exchange calculators during graded events. If your calculator fails during a graded exercise, I am not responsible to furnish a substitute. Class preparation is your individual responsibility.

3. Evaluations:

- a. *ACADEMIC DISHONESTY*: Representation of other's work as your own will not be tolerated. Cheating on examinations, quizzes, and homework and the false representation of work will be interpreted as academic dishonesty. Academic dishonesty will be subject to disciplinary action as outlined by the UT Tyler Student Guide on Conduct and Discipline.
- b. *Homework sets*: Homework problems will be assigned approximately every two weeks (there will be six homework assignments during the semester). All homework is mandatory and becomes part of your grade. As an engineer your goal is to make a clear, logical, and professional presentation of your work, which is both accurate and correct. As such, both the presentation and the accuracy of your work is important, and both will be graded. It is critical that you show all of your work and leave "footprints" so that it can be easily followed. No guess work should be required to see what you did. For each homework problem, the corresponding topic and numerical answers will be provided. You are encouraged to work in groups, but the work that you turn in should be your own. Homework is *due* at the beginning of class.
- c. *SACHE courses*: Additional safety hours will be gained using the AICHE Safety Certification. These consist of two courses that will be assigned (approximately 5 h of videos), which you must watch and test, prior to turning results in via Canvas. Additional procedural information will be provided on the Canvas worksheet.
- d. *Process safety case studies*: The process safety project will be assigned at the beginning of the semester and due at the end of November – in the form of a written report and oral presentation. The project will be qualitative in nature, where the student will use process safety knowledge to make recommendation following the investigation of a safety incident. You will be evaluated based on the approach and thought process you use. You are encouraged to work in groups, but the work that you turn in should be your own. Turning in the same solution to the project as another student will be considered plagiarism. Additional procedural information will be provided on the Canvas worksheet.
- e. *Late submissions*: It is a principle of professionalism that "**Professionals are not late.**" A "COORDINATED LATE" submission occurs when you will miss the due date for a graded assignment, and you contact me in advance. Notification immediately before the submission will not suffice. Point cuts up to the amounts below may be assessed for a "COORDINATED LATE" submission:
 - 0-48 hours late Deduction of 50% of the earned grade
 - > 48 hours late No creditObviously, there are circumstances that will occur and make a timely submission impossible, and I will work with you when and if they occur.

All forms of evaluation in this course must be properly documented. As you are having your work reviewed, it is likely that you might receive help from your classmates, just simply document it. Information from the course textbooks (equations and outlines of procedures), class notes, or me is considered immediately available to all students and need not be acknowledged or documented with one exception. **YOU ARE REQUIRED TO ACKNOWLEDGE AND DOCUMENT ALL OTHER ASSISTANCE AND REFERENCES USED.** Documentation will be accomplished in accordance with any manual for writing, footnote or endnote, for papers, but for written homework, just place the documentation right at the point you received help using "Who and what" assistance.

- f. *Participation grade*: Students are expected to be engaged in class and outside of the class. At their own discretion, the instructor may assign a participation grade (2 points in addition to the 100 points distributed below) to each student based on the following observations:

- Attendance in class and punctuality;
- Level of participation in class, asking questions about the material and answering questions from the instructor;
- Engagement in sessions, demonstrating initiative to work on problems, and actively participating in the discussions.

Attendance in class is the component with more weight on participation. A student that attends every class, but otherwise is not respectful nor active will not receive a participation grade.

g. *Midterm Exams and Final Exam:*

There will be two Midterm exams and one Final exam. The Midterms will be fifty-five minutes long, and the Final will be two hours long. The dates for exams are included in the course schedule. Official reasons for missing an exam are outlined in the “Student Handbook”. You are required to take a make-up exam, regardless of your reason for missing the scheduled exam. Report any conflict to me as soon as possible prior to the exam. You can use a **TI-30 calculator** (or FE equivalent), and ***an equation sheet will be provided by the instructor.***

4. Grading:

Grades will be based entirely on the student’s demonstrated ability to develop detailed, neat, organized, and correct solutions to the problems presented. Correct answers accompanied by incorrect, incomplete, or untidy solutions may receive no credit.

You need at least 60 points total to pass the course with a C grade. You need to be above the class average to receive an A grade.

5. Assigned readings:

The class schedule will include assigned reading for every lecture. Students who read the corresponding sections of the book *before each class* will certainly make the most of the lectures, so this is highly recommended. In addition, the instructor will periodically post the lecture notes on the course website. Doing the assigned reading prior to class will help you to understand the material presented during the instruction and will fill in gaps for things we do not cover (***I will not cover everything***). It will also make you more familiar with terms and concepts to be covered.

6. Collection of Student Work:

Throughout the semester I will collect student work (best, average, and worst) for the ABET course and outcomes notebooks. This will require me to make a copy of your work, keep your original and return a copy of the graded work to you. I will not draw attention as to what level of work you accomplished.

11. **Grade Replacement/Forgiveness and Census Date Policies** - Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated.
