**Description of Course Content:** Commercial Construction. In this course you will learn how construction managers deal with specific phases in the construction process relating to commercial construction. The construction industry is a unique collection of planners, design professionals, manufacturing firms, and tradespeople. The success of the industry is a testimonial of the combined expertise of these individuals and firms.

CMGT 4385 is a senior level course for students preparing to enter the commercial construction sector and project management of commercial construction projects that includes aspects of design, bidding/estimating, presentation, value engineering, contracts/negotiation, subcontractor relations, cost controls, management during construction, close-out, and post- construction requirements.

**Course Objective:**

1. Explain the process of planning sitework investigation and site logistics.
2. Explain various methods used for foundation systems.
3. Demonstrate ability to identify and read a full set of plans.
4. Explain methods used in the testing and evaluation of soils on the building site.
5. Explain various methods of protection during excavation and equipment selection.
6. Explain concepts of roadway pavements, curbs and sidewalks, parking areas, storm and sanitary sewer lines, storm water management, and street lighting.
7. Explain process of fabrication and erection of structural steel for building frames.
8. Explain various roof design principles and the materials used in roof construction.
9. Explain various finish-out processes for both interior and exterior.
10. Explain the process of shop drawings and learn how to review shop drawings.
11. Explain concepts, methods, and techniques related to managing a commercial project.

12. Explain the process of commissioning and steps to properly test and inspect projects through quality control and assurance measures.

**Student Learning Outcomes:** Upon completion of the course, the student will have:

- An ability to apply knowledge of mathematics, science, and engineering.
- An ability to design a system, component, or process to meet desired needs within realistic constraints like economic, environmental, social, political, ethical, health and safety, manufacturability, and sustainability.
- To identify the types of foundations and the uses of each type.
  
- An ability to read a full set of plans.
  
- An ability to test and evaluate soil on the building site.
- Understand the types of formworks and structural steel for building frames.

**Descriptions of major assignments and examinations with due dates:** There will be three exams (two are the midterms, and one final exam, which will be comprehensive), one project, and several homework assignments. There will be quizzes throughout the semester. Among Exam 1, 2, and Final Exam. See Course Outline for specific dates. The three on-campus exams must be taken during the time specified in the course schedule, and term project presentation must be delivered in person and on campus.

**Attendance:** ALL in-class students are expected to attend the on-campus lecture and in-person regularly. During the lecture, no electronic devices are allowed.

### **Final Project**

Project will be given. All students are to work on them individually using class design parameters set in the course. The final project tests your ability to work as a team as well as your ability to use the techniques discussed in the course to provide accurate work.

### **Quizzes:**

These quizzes are not meant to be tricky, but rather to encourage each of you to review the required information. and reward. The quiz will be during the class and No Make-up quiz. The quizzes are graded. You will have eight quizzes during the semester.

### **HomeWorks:**

I will post assignments on Canvas, and students as groups must upload their responses to Canvas by the deadline, which is usually one week after the homework is posted on Canvas. A homework assignment should be something you are proud of and not something hastily "slapped together". Toward this end, considerable emphasis will be placed on not only getting the correct answer but also on how the solution is presented. Late work will not be accepted. You will have five assignments during the semester.

**Make-up Exams:** All students must take the exams during the time specified in the course schedule. Only extenuating circumstances will be accepted as an excuse for missing the exam. Health related excuses require **medical reports and the signature of a licensed physician** who provided treatment.

### **GENERAL EXAM RULES & CHEAT SHEET**

- The dates for all exams are included in the course schedule.
- Solutions to exams will not be posted on Canvas, but you may stop by the office and see exam solutions.
- All exams are closed book. You are only allowed to bring your writing instruments, erasers, and NCEES approved calculators. Topics to be tested will be announced in class and on Canvas one week prior to the exam.
- The instructor will set questions from material taught in class. The meaning of "taught in class" includes verbal instructions or written notes on the white board and Canvas, briefing/ presentation during field trips, observation during field work/ experiments. They do not necessarily appear in the textbook, distributed class notes, or homework. It is very important that you attend the class activities and take additional notes.
- To discourage students from focusing narrowly on only a few questions, no practice exam will be given. There are enough self-practice problems in the textbook at the end of each chapter.
- The Exam is not a group work and if any student is caught cheating, both will be given an "F" for the exam
