**Course Objectives<sup>2</sup>:** By the end of this course students will be able to:

1. Analyze single- and multi-stage amplifiers. [1]
2. Analyze the transfer characteristics of a differential amplifier. [1]
3. Analyze a simple operational amplifier. [1]
4. Analyze systems involving feedback and determine their closed-loop gain, input impedance, output impedance, and frequency response. [1]
5. Design simple active filters to meet frequency-response requirements. [1]
6. Determine the conditions under which circuits with feedback will oscillate. [1]
7. Design simple nonlinear oscillator circuits to meet specified requirements. [1]
8. Derive the transfer characteristics of a CMOS inverter by graphical or analytical methods. [1]
9. Determine  $V_{IL}$ ,  $V_{IH}$ ,  $V_{OL}$ ,  $V_{OH}$ , and noise margins of a CMOS inverter from its voltage-transfer characteristic. [1]

10. Design simple logic gates using static CMOS, pseudo-NMOS, pass-transistor logic, and dynamic logic. [1]

**EENG 4309.031: Electronic Circuit Analysis II**

**Outline**

**Course Description**

This course covers small-signal models of semiconductor devices and amplifier circuits including op-amps at the transistor level. Electronics topics include BJT and MOSFET circuits and extend to the frequency response of transistor amplifiers and the use of cascaded amplifiers to increase gain and bandwidth. Emphasizes real devices and their performance, analog IC design concepts, and building blocks.

### Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement

Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a “W” grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university.

For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
