**COURSE INFORMATION:**

Catalog Description: Vibration analysis and prediction of the free and forced dynamic behavior of mechanical systems; first, second, and higher order systems; vibration isolation and absorption; vibration characteristics of rotating machinery.

**PRE-REQUISITES:**

ENGR2302 (Dynamics), MATH 3305 (Differential Equations) with a minimum “C” grade.

**COURSE SYLLABUS & TOPICS COVERED**

The following topics from the book will be covered. You are required to review all the material posted in Canvas and read the textbook for supplemental information and additional solved problems.

Chapter 2: Response to Harmonic Excitation, Sections: 2.1 to 2.6  
Chapter 4: Multiple-Degree-of-Freedom Systems, Sections: 4.1 to 4.7  
Chapter 5: Design for Vibration Suppression, Sections: 5.1 to 5.4, 5.7, 5.8  
Chapter 6: Distributed-Parameter Systems, Sections: 6.1 to 6.4  
Chapter 8: Finite Element Method, Sections: 8.1 to 8.4

The topics noted above will be organized and covered in class in the following manner:

- a) Introduction and Modeling Systems
- b) Single-Degree-of-Freedom Systems (SDOF Systems)– Free Undamped and Damped Vibrations
- c) SDOF Systems – Forced Vibrations – Response to Initial Conditions

- d) SDOF Systems – Steady State Forced Vibrations
- e) Systems with More than One Degree of Freedom
- f) Continuous Systems
- g) Finite Elements

My handwritten notes for the topics a) through g) will be posted in Canvas.

### **ASSESSMENT: HOMEWORK:**

Homework is considered to be very important to fully understand the course material. Completing your homework is an absolute necessity to do well in this course. Therefore, I strongly urge each of you to complete the homework assignments in a timely manner. Homework assignments and solutions will be posted in Canvas. Homework will **NOT** be collected or graded. You are encouraged to work in groups to solve homework problems and learn from each other.

### **EXAMS:**

Closed-book, closed-notes exams will be given after completing a reasonable amount of material from the text as shown earlier. A final 2-hour **COMPREHENSIVE** examination will be given during the final exam week. You may use a one-page, self-written notes (cheat sheet with no problem solutions of any kind) for reference in each of the exams and the final examination. The cheat sheet will be collected with exam papers. A formula sheet will be posted in Canvas before each exam and it will also be included with the exam. If you miss any exam without getting **prior approval from me at least one week before the test date**, your exam score will be counted as zero in the calculation of your final course grade. If you were given an official excuse, then the percentage will be added to your final exam. **Please note that there are no makeup exams.**

### **FINAL GRADES:**

### **NOTE**

In computing your final course grade, your lowest exam grade (from exam 1, 2 or 3) will be replaced by the final exam grade if you did really well in the final exam. In other words, if your final exam grade is better than any of your earlier exam grades, it will be used to replace the lowest grade and will also be used as your final exam grade. Since final exam is a comprehensive exam this is an incentive for you to do really well in the final exam.

Course syllabus, and all course material will be posted in Canvas. Please review all the material posted in Canvas on a regular basis. I will use Canvas to post announcements and contacting students by e-mail.

### **CALCULATOR POLICY:**

Use your own scientific calculator **TI-30X IIS** or any FE Exam approved calculator at each exam. You are not be allowed to use any other calculator or store any class material in the calculator during the exams. You cannot have i-phones, i-pads, i-watches or other electronic devices with you. If you bring i-phone or other electronic devices to the room, please leave them in your bag. I strongly recommend that you buy the TI-30X IIS calculator before the classes begin and get familiar with its use before the first examination.

### **ATTENDANCE:**

**Regular attendance is required.** Attendance will be taken in each class for my records. In case you have to miss a class, it is your responsibility to keep up with the class work and be informed of all announcements made on home works, exams etc.

**THERE WILL BE NO MAKE-UP EXAMS.** The percentage of any exam missed by a student will be added to his/her final comprehensive exam only if prior excuse is granted. Excuses will be given only if you have to miss an exam due to emergencies (such as medical and other emergencies). Please inform me as soon as possible before or immediately after the exam. Class average for each exam will be announced in class and also posted in Canvas after each exam. You can use these class averages to estimate your standing at any time. If the class averages for the 3 exams are a, b, and c, then the overall class average before final exam will be  $0.2(a+b+c)$ . Compare this with your numbers to see your status. Cut-offs for A, B, C, D, and F grades will be determined only after the final exam grades are known. If your grade is consistently at or close to the class average you will get a "C" grade. Final course grades will be determined on the basis of the class average. If you miss any exam without getting **prior excuse and approval from me**, it will be counted as zero in the calculation of your final course grade. If you intend to be absent for a university-sponsored event or activity, you (or the event sponsor) must notify me at least a week prior to the date of the planned absence.

### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
