**Course Details**

Description: This course covers fundamentals of HVAC, including properties of moist air, psychometrics, psychrometry of air conditioning processes, vapor-compression refrigeration cycle, design conditions, and load calculations. Components, equipment, and common systems, as well as software for HVAC with emphasis in whole building energy simulation are introduced.

Credit hours: 3 credit hours with 3 hours of lecture per week

Prerequisites: Graduate standing

Textbook: There is not a formal textbook for this course, but the main guide will be W. P. Jones, Air Conditioning Engineering, Fifth Edition, available of free download from the library.  
Other references that are recommended and will be used are the ASHRAE Handbooks with emphasis in the handbooks of Fundamentals and Systems and Equipment.

**Expected Learning Outcomes**

By the end of this course students will be able to:

1. Apply psychrometric concepts to air conditioning processes.
2. Identify appropriate design condition for a location and building.
3. Recognize the parameters affecting load calculations.
4. Describe critical parameters for computer models in HVAC.

**Evaluation activities**

- Exams: there will two exams and the final exam. The final exam is comprehensive.
- Project: a project will be assigned to be developed during the whole semester, with specific days to present advances. Rubric for the grading of the report will be given with the project description.
- Assignments: assignments on various topics related to the content of the course will be given.

### **9. Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

### **10. State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
