## COURSE DESCRIPTION

This course provides the student with a solid understanding of the history, rationale, evidence, potential risks, consequences, regulation, control, and legal and ethical issues of the use of substances, methods, devices, and practices to enhance athletic performance and recovery. The major focus will be on doping and supplements.

## **COURSE PREREQUISITES**

There are no prerequisites for this course. However, it is assumed that each student has successfully completed a course in Exercise Physiology and/or Anatomy & Physiology at either the undergraduate or graduate level.

# **COURSE MATERIALS**

<u>Textbook</u>: There are no required textbooks for this course. Ancillary readings (review and research articles) will be provided in respective reading assignments throughout the course. For those wanting a textbook recommendation, the following is a good resource: Moffatt DR and Chester N. <u>Drugs in Sport (8th edition)</u>, Routledge, 2022 (ISBN-13: 978067560294).

<u>Additional resources</u>: Additional course materials and resources will be made available in Canvas, including the syllabus, assigned readings, additional videos, and a detailed schedule.

# **COURSE OBJECTIVES**

The course has several general objectives, listed below. More specific objectives are listed with each lesson of the course. Upon successful completion of this course, the student shall be able to:

- 1. Describe the theory, practice, efficacy, and potential adverse effects of pharmacological aids used for the enhancement of sport and exercise;
- 2. Describe the theory, practice, efficacy, and potential adverse effects of physiological aids used for the enhancement of sport and exercise;
- 3. Describe the theory, practice, and efficacy of nutritional aids used for the enhancement of sport and exercise;
- 4. Describe the theory, practice, and efficacy of mechanical aids used for the enhancement of sport and exercise;
- 5. Describe the theory, practice, and efficacy of psychological aids used for the enhancement of sport and exercise:
- 6. Describe the national and international regulation of anti-doping in sports today;
- 7. Describe the general testing protocols and biological passport monitoring used by anti-doping agencies in sports today;
- 8. Describe the challenges and issues that will likely be faced by anti-doping agencies in the future.

This course addresses these objective through the following:

- 1. Study of basic facts, concepts, and theories of various ergogenic aids;
- 2. Critically reading and discussing research related to various ergogenic aids;
- 3. Discussing in writing questions and viewpoints related to ergogenic aids;
- 4. Applying theoretical concepts in the discussion of ergogenic aids.

### COURSE REQUIREMENTS AND EVALUATION

<u>Module Quizzes</u>: There will be a quiz at the end of each unit. These untimed quizzes are objective in format, consisting of multiple-choice, true-false, and matching questions over material from lectures and assigned readings. You have two attempts at each module quiz with the higher score counting.

<u>Written Assignments</u>: For each unit, students will complete a set of essay questions related to the material from the lectures and assigned readings. Some may require you to do additional review of the literature.

<u>Scientific Papers</u>: Students will be required to write two papers about specific topics related to ergogenic aids. The purpose of these assignments is to promote a deeper understanding of a particular area, to provide students with practice of critically reviewing and summarizing research, and to provide students with practice writing scientific papers. Details about these assignments, as well as potential topics, will be provided in Canvas.

<u>Deadlines</u>: This course will mostly be self-paced, with suggested deadlines to keep you on track. You may work ahead in the course. There are three major deadlines in this course this summer:

- · Sunday, May 26: Introduction assignment (for Census purposes)
- Friday, August 2: Units 1-4 assignments and 1st paper
- Friday, August 9: Unit 5 assignments and 2nd paper

**Evaluation**: Grading for the above assignments will be weighted as follows:

An advantage of the online format is that the lecture material is there for you to review whenever you want. In an online course, more time must be devoted to participation in discussions than is traditionally spent in classroom discussions. Time for completion of assignments, readings and other materials, reviewing for comprehension, and preparing for exams should be similar in this online course as in any other course. As a rough guide, you should plan to spend approximately 10 – 15 hours per week on this course. The actual amount of time required will, of course, vary from one person to another. It is absolutely essential that you do not fall behind.

The Census Date is the deadline for many forms and enrollment actions that students need to be aware of. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- · Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- · Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- · Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

#### STATE-MANDATED COURSE DROP POLICY

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university.
