**Course Description:** Emphasis on the origin, nature and course of musculoskeletal and neurological disorders using biomechanical intervention and treatment planning to support occupational participation and engagement. Focus on basic biomechanical assessments and interventions.

Credits: 3

**Course Objectives:**

1. Analyze human movement and its impact on occupational performance.
2. Correlate muscle actions to occupations and activity
3. Demonstrate proficiency in assessment and documentation of muscle strength, joint range of motion, and movement patterns, to meet standards for reimbursement and communicate to patients, caregivers, and other professionals the need for occupational therapy services, according to accepted terminology.
4. Demonstrate knowledge of safety and sound clinical judgement to provide recommendations and training in functional mobility, including physical transfers, wheelchair management, and mobility devices.
5. Describe and correlate prehension and grasping patterns to occupational performance.
6. Apply foundational knowledge, previous professional experiences and new academic learning to fieldwork and community engagements to meet the needs of clients in various contexts and cultures reflecting ethical practice.

**Connection to the MOT Curriculum**

**Essential Knowledge and Professional Skills**

This course offers essential foundational knowledge and professional skill that is built upon in courses taught later in the curriculum as it applies specifically to practice areas such as pediatrics, physical rehabilitation, work programs, geriatrics, and psychosocial settings. This course provides foundational knowledge in movement in context and its impact on occupational performance and participation. Course content provides foundational knowledge in human systems, structures, functions and conditions as they relate to client factors and performance skills.

### **Grading Policies**

Written assignments are graded on content, style, clarity, conciseness, and comprehensiveness. Written assignments are expected to reflect the guidelines in the Publication Manual of the American Psychology Association (APA) 7<sup>th</sup> edition. Some of the required assignments in this course may be checked for plagiarism using Unicheck.

Class preparation: All students are expected to complete assigned readings and review online materials before taking quizzes and/or attending software.

Late assignments: Assignments are due on the date indicated in the syllabus. The grade will reflect 10% off each day late, not accepted after day 3 for anything other than completed. All assignments must be completed, with or without credit, to receive a grade in the course.

Laboratory Passing Policy: For courses where your instructor has an embedded laboratory component with a competency or 'check off,' students will receive three attempts to ensure entry level skills are demonstrated. It is imperative students pass both laboratory and didactic sections of each course in order to pass the overall course. If the first attempt at a laboratory exam is not successful, the second attempt will be offered with the highest passing score of 75%. If the second attempt is not successful, a third attempt will need to be passed in order to continue in the course. Should the third attempt not be successful, the student will receive a 0 and need to discuss options with the Course Instructor. The student will meet with the Program Director who will request the student to return to the course next time offered to ensure successful skills in the required practice area. For this reason, it is imperative students study appropriately and

pass the laboratory competencies and meet the course objectives for safety, skill, efficiency, and entry level performance.
