Course Description: Application of client-centered outcomes in evaluation for older adulthood practice including neurological, musculoskeletal, general medical and acquired conditions. Practice and application of standardized assessments and service delivery.

- 4. Plan evaluation processes for a variety of cases, including roles of OTR and COTA within desired treatment plan.
- Apply foundational knowledge, previous professional experiences and new academic learning to fieldwork and community engagements to meet the needs of clients in various contexts and cultures reflecting ethical practice.

Essential knowledge and Professional Skills

The third of three courses focusing on essential knowledge and professional skills in evaluation and assessment across the lifespan, this course focuses on

assessment and communication of conditions and abilities in the middle and older adult population. Within the middle and older adult populations, the student will employ previous knowledge regarding older adult practice and refine skill sets in assessment and evaluation. Focus is on administration, interpretation and communication of assessment results to families and clients.

Full policy details are printed on each Grade Replacement Contract. The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware.

These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)

- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid.

State-Mandated Course Drop Policy

- 1. "Cheating" includes, but is not limited to:
