Other preferred factors include a doctoral program with APA accreditation and a clinical psychology and/or health or medical psychology program emphasis. Also important are applicant characteristics that lend diversity, fresh outlook, or unique skill(s) to the cohort. Completion of the dissertation proposal is required. The number of hours of experience in testing and psychotherapy, while important, are less so than the above elements.
