Course Description

This course introduces nursing care required for individuals who have been diagnosed with chronic physical or mental conditions. Emphasis is on using evidence-based practice for professional collaborative

management of chronic illness. A variety of clinical experience will be used to apply caring and evidence-based professional nursing care for persons with chronic conditions.

Course Learning Objectives

Upon successful completion of this course, the student will be able to:

1. Professionalism: Demonstrate professional behavior and ethical decision-making processes considering the unique needs of patients with chronic health issues.
2. Patient-Centered Care: Select and apply a plan of care that is patient-centered and holistic, reflecting the specialized needs of patients dealing with chronic health conditions.
3. Evidenced-Based Practice (EBP): Recognize the role of evidence-based practice in providing safe and effective care for the chronically ill patient.
4. Informatics & Technology: Examine the importance and use of informatics and technology in delivering quality care and developing astute clinical decision-making skills in the chronic care environment.
5. Quality Improvement: Compare quality improvement initiatives for chronic health conditions and its relation to the improvement of patient outcomes and healthcare delivery systems.
6. Teamwork and Collaboration: Demonstrate effective inter-professional communication skills to achieve quality patient care through collaborative efforts focused on chronic care considerations.
7. Wellness and Prevention: Recognize the benefits of health and wellness based initiatives, and prevention of further complications in promoting healthy outcomes for patients with chronic disorders.
8. Leadership: Examine the effect of leadership and patient advocacy on nursing practice directed to the chronically ill patient.
9. Safety: Apply appropriate safety measures that reduce patient safety risks and fosters a safe working environment in the chronic care setting.
10. Strengths: Determine how Strengths (signature talent themes) influence the role of the student nurse and clinical decision-making.

Grading Policy and Criteria

Specific guidelines and grading criteria for all assignments are in the Modules. Final grades for the course will be determined based upon the following point assignments:

- A - 90-100
- B - 80-89
- C - 75-79
- D - 60-74
- F - Below 60

Final course grades less than 75 are not rounded up.

The simple average of all exam grades including a final must first be at or above 75% in order to pass the course. Once the student has achieved a simple exam average of 75% or higher, course grades will be determined based on the weighted calculation of exams and other required course work.

Late policy: 5% will be deducted each day an assignment is past due unless prior arrangements have been made with your course faculty. Extenuating circumstances may apply.

EHR Go: Students will use a subscription to access EHR Go. There are seven terms available and each is renewable (cost per student) as of 5/1/2018

To get payment through financial aid, students can purchase in the bookstore. A separate option is to purchase online through the vendor at www.ehrgo.com.

Quarter coverage (12 weeks): \$45

- Semester coverage (16 weeks): \$65
- Academic year coverage (40 weeks or about 9 months): \$105
- Annual coverage (52 weeks): \$120
- Extended coverage (up to 18 months): \$155
- 2-year coverage: \$195
- 3-year coverage: \$285

InPlace Clinical Placement System: This is where clinical scheduling and clinical logs are recorded.

- 1-year cost is \$67 at InPlace, \$89.35 at bookstore (prices subject to change over time)
- Program/lifetime cost is \$130 at InPlace, \$173.35 at bookstore

Subscription, for the yearly subscription, will be per academic year running August 1st to July 31st. There is a 2-month leeway on purchase prior to academic year start. Purchasing 2 months prior to Academic Year gives a 14-month subscription. Any earlier will result in a short year license.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall 2018, the Census Date is Monday, September 10, 2018.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Monday, September 10, 2018) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date).
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment.
- Completing the process for tuition exemptions or waivers through Financial Aid.

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

Student Standards of Academic Conduct

Disciplinary proceedings may be initiated against any student who engages in scholastic dishonesty, including, but not limited to, cheating, plagiarism, collusion, the submission for credit of any work or materials that are attributable in whole or in part to another person, taking an examination for another person, any act designed to give unfair advantage to a student or the attempt to commit such acts.

- i. "Cheating" includes, but is not limited to:
 - copying from another student's test paper;
 - using, during a test, materials not authorized by the person giving the test;
 - failure to comply with instructions given by the person administering the test;
 - possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
 - using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
 - collaborating with or seeking aid from another student during a test or other assignment without authority;
 - discussing the contents of an examination with another student who will take the examination;
 - divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
 - substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
 - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
 - falsifying research data, laboratory reports, and/or other academic work offered for credit;
 - taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
 - misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially
- ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- iv. All written work that is submitted will be subject to review by plagiarism software.
