Course Description

This course is an introduction to the concepts, theory, and practice of Emergency Nursing. Students will describe the foundations of emergency nursing practice and demonstrate mastery of the introductory concepts of medical and surgical emergencies, and trauma emergencies.

Pre-Requisite or Co-Requisite: NURS 4626 Caring for the Acutely III or BSN.

Course Learning Objectives

Upon successful completion of this course, the student will be able to:

- 1. Describe the foundations of emergency nursing practice and demonstrate mastery of the introductory concepts of medical and surgical emergencies, and trauma emergencies.
- 2. Professionalism. Students will network with emergency nurses through the Emergency Nurses Association and engage in professional enhancement activities.
- 3. Patient Centered Care. Students will recognize the emergency/trauma patient's individual's preferences, values, and needs; anticipate the uniqueness of the patient and their family, and incorporate the patient and family in plans of care.
- 4. EBP. Students will synthesize and apply evidence, along with clinical expertise and patient values, to improve the emergency/trauma patient's outcomes.

- 5. Informatics & Technology. Students will demonstrate how information and technology in the emergency department can help to communicate, manage knowledge, mitigate error, and support decision-making.
- 6. Quality Improvement. Students will demonstrate how to use a systematic, data-guided approach to continuously improve outcomes and processes for the emergency/trauma patient and the emergency department systems.
- 7. Teamwork and Collaboration. Students will reflect on the vital function of interprofessional teams in the emergency/trauma arena and demonstrate how emergency teams foster communication, mutual respect, and shared decision-making to achieve quality patient care.
- 8. Wellness and Prevention. Students will assess health and wellness in an emergency/trauma patient/family to promote health outcomes.
- 9. Leadership. Students will promote the practice of professional emergency nursing through leadership and advocacy.
- 10. Safety. Students will discuss appropriate measures to promote quality and a safe environment for patients, self, and others in the emergency department.
- 11. Strengths. Students will identify and apply their Strengths (signature talent themes) to influence clinical decision-making.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <u>http://www.uttyler.edu/registrar</u>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date).
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment.
- Completing the process for tuition exemptions or waivers through Financial Aid.

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- i. "Cheating" includes, but is not limited to:
 - copying from another student's test paper;

 - possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
 - using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
 - collaborating with or seeking aid from another student during a test or other assignment without authority;
 - discussing the contents of an examination with another student who will take the examination;
 - divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
 - substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
 - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
 - falsifying research data, laboratory reports, and/or other academic work offered for credit;
 - taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
 - misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially
 - ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
 - iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
 - iv. All written work that is submitted will be subject to review by plagiarism software.
