4. Create an innovative multimedia presentation using emerging technologies and information science that analyzes the nursing shortage and improves patient care outcomes.

5. Integrate socio-cultural competence, effective communication, and state, national and international quality indicators to facilitate patient centered care within community organizations.

Graded Course Requirements Information:

The major assignments in this course will require students to:

List of Assignments is as follows

1. Introductory Discussion Board#0-Introduction to the class and peers: This discussion board will allow you to introduce yourself to the faculty and class peers and write a succinct biography that includes your top 5 strengths from the Strength Finders Assessment to get to know one another, a post a photo of yourself.

2. DB#1-: you will discuss the delivery of care in your clinical or employer's agency. Furthermore, you will discuss the delivery of care system based on the framework discussed by Piña et. al (2015) or as discussed in additional references such as: Dangremond (2015), and Shi and Singh (2022). You will be required to discuss: In what ways is this system effective? How could it be improved? Discuss if you think the ideas proposed by Porter and Lee (2013) could improve your organization?

Also, you will discuss briefly describe what you believe are the top 3 challenges (e.g., legal, financial, patient-specific needs, etc.) that your organization faces with this model of care delivery.

DB#2- For this DB, you will focus on workflow design, emerging technologies, performance improvement, and risk management strategies that are meant to assure positive patient outcomes. You will discuss how you see these working together in your facility, especially regarding collaborative practice?

3. DB#3- This DB will require that you review the module content on sociocultural competence and then you will be required to take any one of the Implicit Bias Association Tests (from Harvard University) and upload your results (pdf document). From there you will discuss with the whole class your feelings about the test, implicit bias, and what you learned from Dr. Kimberly Papillon, and ways you plan to increase cultural competence as well as communication skills you plan to use as a nurse administrator/leader with other healthcare professionals and patients in the healthcare setting.

4. Scholarly Papers

You will write two scholarly papers in this course that reflect the environmental scan report (ESR). Detailed instructions are provided in Canvas.

5. Multimedia Video Presentation

Innovative Video Presentation- You will create an innovative multimedia presentation that explores the nursing shortage and its' impact on patient care outcomes across the healthcare continuum.

NOTE:

Participation is defined as full participation in group assignments and documented in Canvas through the group pages and assignments (Group discussion, group assignments, peer feedback, collaborations, and file uploads that demonstrate student participation).

a. Completion of 37.5 clinical hours with an approved preceptor.

b. Additionally, a clinical evaluation will be required at the end of the course by the student of the preceptor and clinical agency.
