Below is a copy of a fee waiver form for The University of Texas at Tyler. Read the instructions carefully and return the form and supporting documents for further review. (The university reserves the right to update the information on this form as necessary.)

Introduction

The University of Texas at Tyler Office of Admissions has a fee waiver program to assist undergraduate students for whom a payment of the admissions application would cause a serious economic hardship. Based on various economic factors, waivers are available to individuals who qualify under one or more outlined conditions.

The application fee waiver committee considers all who apply and provides the required documented proof of self or family economic status. Applicants who meet the eligibility requirements will be considered for a waiver.

Fee Waiver Guidelines

The application fee waiver covers the cost of applying for admission to The University of Texas at Tyler's undergraduate programs. Only one waiver per semester, NOT to exceed two within a 12-month period will be assessed. Applicants who require an evaluation of foreign credentials do NOT qualify for a fee waiver. Post-baccalaureate and international applicants do not qualify for the fee waiver option and are required to pay the application fee.

II. Applicants MUST demonstrate proof that the application fee causes a serious economic hardship. Submit at least one of the following to Enrollment Services for consideration:

- a) Freshman applicant should submit an original SAT or ACT test waiver form from high school counselor or principal;
- b) Document showing applicant's family receives public assistance or participates in free or reduced price lunch program;
- c) Proof applicant is a ward of the state or resides in foster home;
- d) Document showing Financial Aid EFC index number is 00000
- e) Proof of articulation agreement with outside institution.
- f) Proof dependent applicant's total family income is at or below the following economic index, *before taxes*.
