President Updates, Dr. Philley

- Break important
- Thank you for welcome
- What do I plan to do this summerSB? Meeting with lots of stakeholders (internal and external); listening to faculty, staff, and students to hear difference perspectives; working with leadership to create a forum for meeting
- Streamline processes is very important
- Does not plan to start over with strategic plan; will look to narrow down and focus plans
- Convocation in August great kick off; will hear from student, faculty, and staff Senate as well as Dr. Philley
- Heard that more education is needed for chairs, deans, etc.; working with system to get started (will hear in next week); provided in August
- SB 17 internal audit to show we are in adherence and will also have an external audit
- Will comply with all laws
- Dwain will talk about budget; month of June to mid-July will be going over and taking hard look at what is needed
- Plan a big retirement for Howard Patterson
- UT System would like to do investiture for Dr. Philley on October 1 and focused on what matters our students

Associate Provost for Academic Success and Dean of Undergraduate Studies, Dr. Colleen Swain, "AI and your syllabus"

- Workforce expects our grads to be capable of using AI
- CETL email that discusses required language for AI on syllabi (section required)
- Option to select one of three categories:
 - o AI encouraged and appropriate acknowledgement expected
 - o AI permitted for specific assignments and appropriate acknowledgement required
 - o AI is not permitted in this class at all
- Need to be very clear of expectations for student success
- Language on Academic Affairs page, CETL page, Office of Digital Learning page all have same information available
- Faculty group advising
- Workgroup coming together to implement above
- Training information will be provided soon
- Student pregnancy and parenting laws
 - o Process will work just like SAR for accommodations
 - o Students must opt-in
 - o Will go to parenting liaison, Ashton Maisel
 - Law states pregnant students and postpartum students are allowed excused absence
 - o If notified, congratulate and refer to parents@uttyler.edu
 - Will be new email that looks similar to SAR email
- Dr. Wahlrab encouraged to reach out to Dr. Swain with questions; AI will be very fluid; would like to feel like distrusting students
- Most commonly caught are Grammarly and spell checker Dr. Swain
- Microsoft presented on AI detection it does not work; get false positives especially against students whose first language is not English
- Dr. Banta the students should still be responsible for the thinking; if suspicious, have student explain report
- Dr. Wahlrab come to together with a consistent response; understand how to use productively, explain to students ahead of time, catch use of it
- Dr. Cheryl Parker I tell my students that they are responsible for the output.

- Reiterated reason for summer meeting
- Moving toward the 89th Texas session; will start hearing things; handed to Texas Senate by Lt Governor; childcare; expand healthcare, mental healthcare; many possible positive; looking at Faculty Senates and their role in advising admin; requests to see how SB17 has been handled on campuses (concerned for use as an exclusionary practice); they do not want a litmus test for hiring around DEI; SB 18 also being evaluated (how implemented); mentioned all to just have on radar and not meant to cause freak out; opportunity so show off how awesome we are and not a good idea to predict end of world; working hard to educate the legislature on what higher ed is doing; if you hear things in news and have questions, don't hesitate to reach out to EC who can get more answers for you
